

# Eaton Vance Closed-End Funds 2024 Exempt Interest Earned by State

---

## TAX INFORMATION

Generally, the income dividends paid during 2024 by the various Eaton Vance municipal bond Closed-End Funds were exempt-interest dividends, exempt from federal income tax. However, income dividends paid by these funds may be subject to state or local income taxes and the federal Alternative Minimum Tax (AMT).

The following schedule shows, by state, the source of the income earned by the various municipal bond Closed-End Funds. This schedule may be useful in preparing your state and local income tax returns. This detailed state information is not being reported to the IRS, and is provided to you as an additional service by the Eaton Vance Closed-End Funds.

If applicable, you can determine the amount of dividends earned from investments in your state by multiplying the exempt-interest dividends you received during the year by the percentage shown next to the appropriate state. The portion of any of the funds' exempt-interest dividends subject to the AMT is also listed inside.

Tax-exempt interest earned (including exempt interest dividends from Closed-End Funds) is reportable on Form 1099-DIV. While still generally tax-exempt, the dividends must be reported on your tax return.

The Eaton Vance municipal Closed-End Funds listed below paid taxable distributions in 2024. If you were paid these distributions, they have been reported on Form 1099-DIV.

If you were paid aggregate distributions of less than \$10 for the 2024 tax year, you may not necessarily receive Form 1099-DIV. However, any distributions you did receive will appear on your year-end statement. You are required to report these items on your tax return.
