



US Equities Performance and Volatility – Short Term (3 Months)






CBOE Market Volatility Index (VIX)





CBOE Market Volatility Index (VIX)







Expected Earnings Growth





Yields Over Time











Price to Earnings (FY1)











MSCI World - Country breakdown (12/31/2004 - 12/31/2024)


