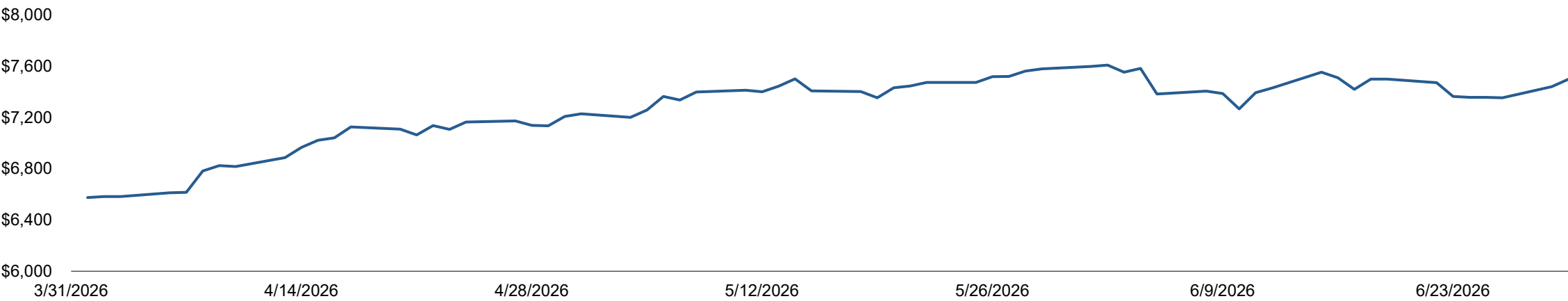

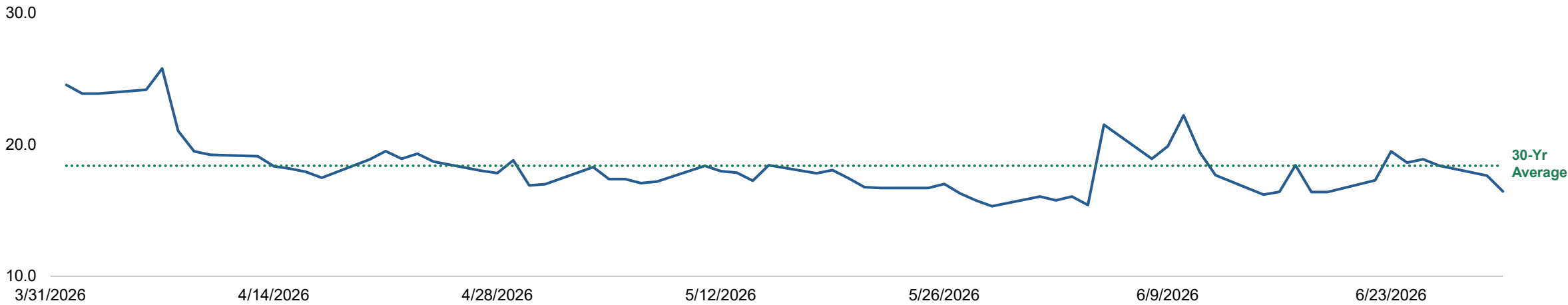

S&P 500 Index



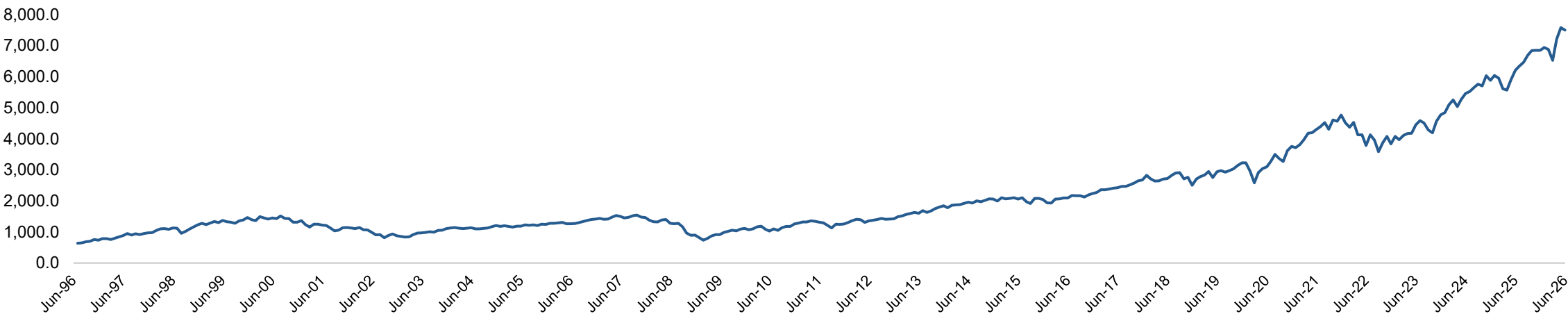
CBOE Market Volatility Index (VIX)



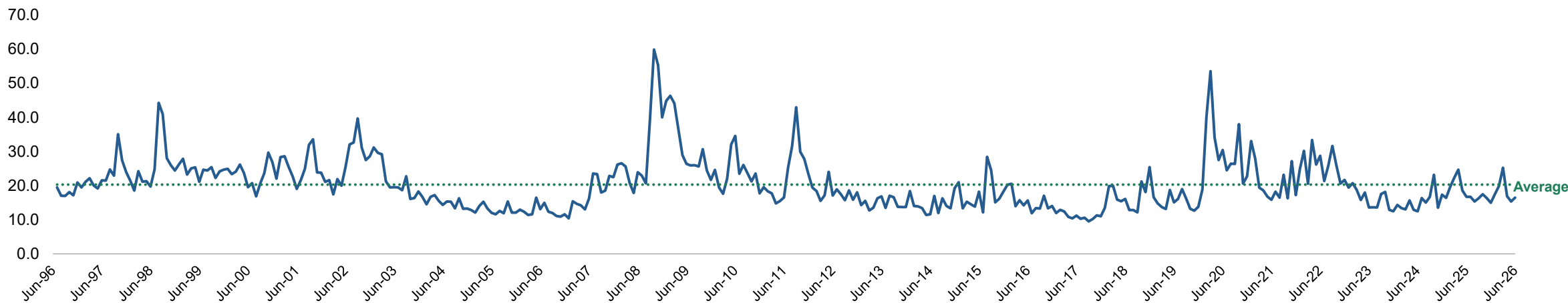

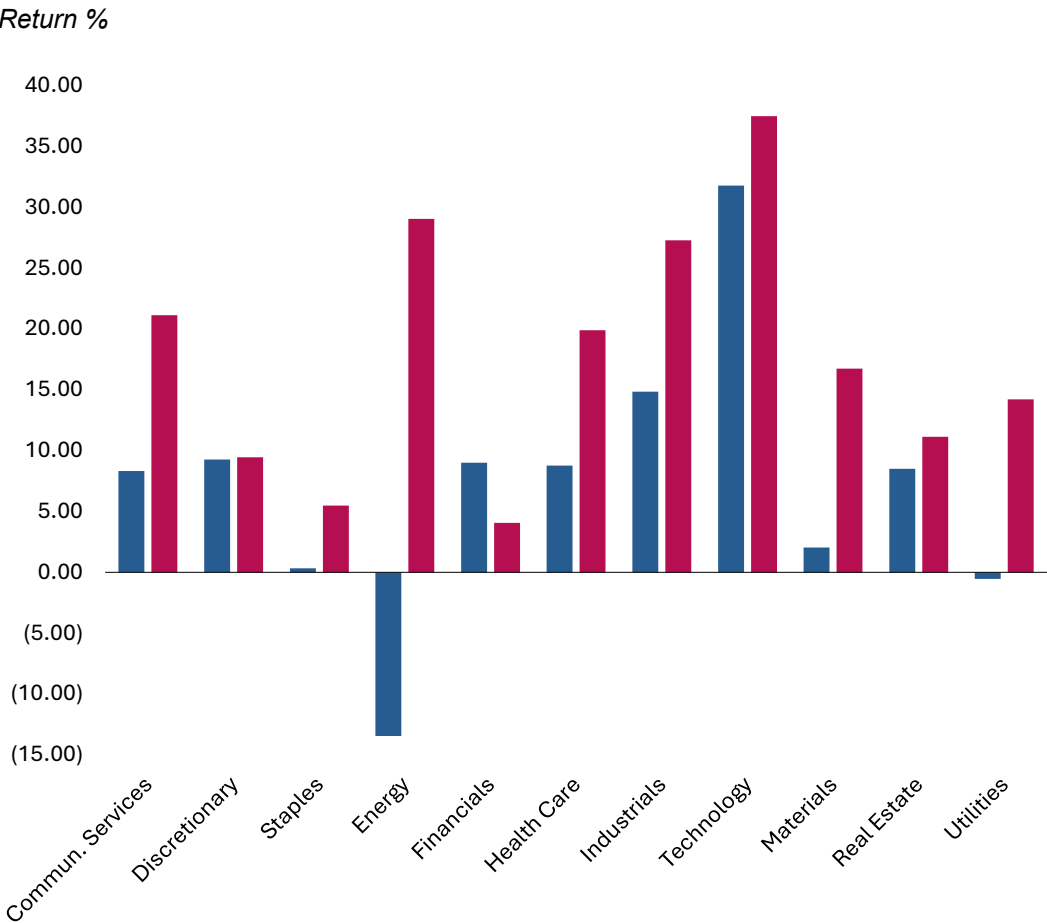
S&P 500 Equal Weight vs. Cap Weight (1-Year)



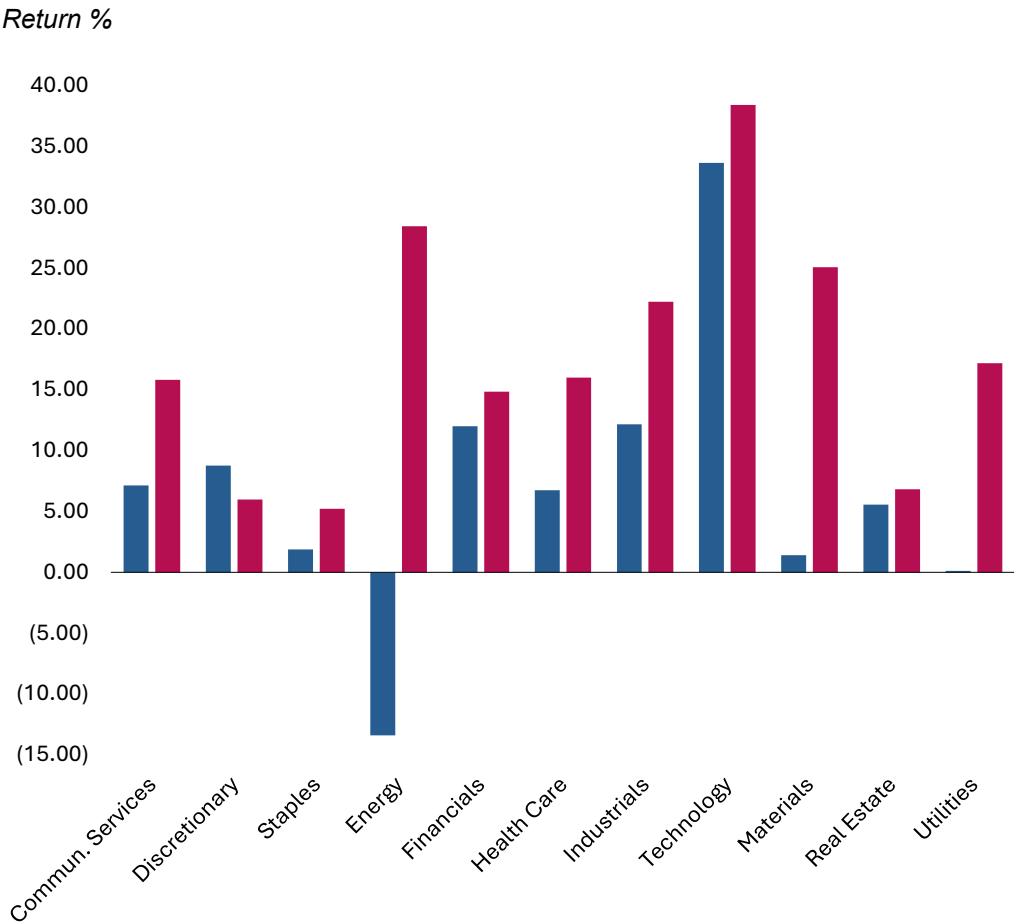

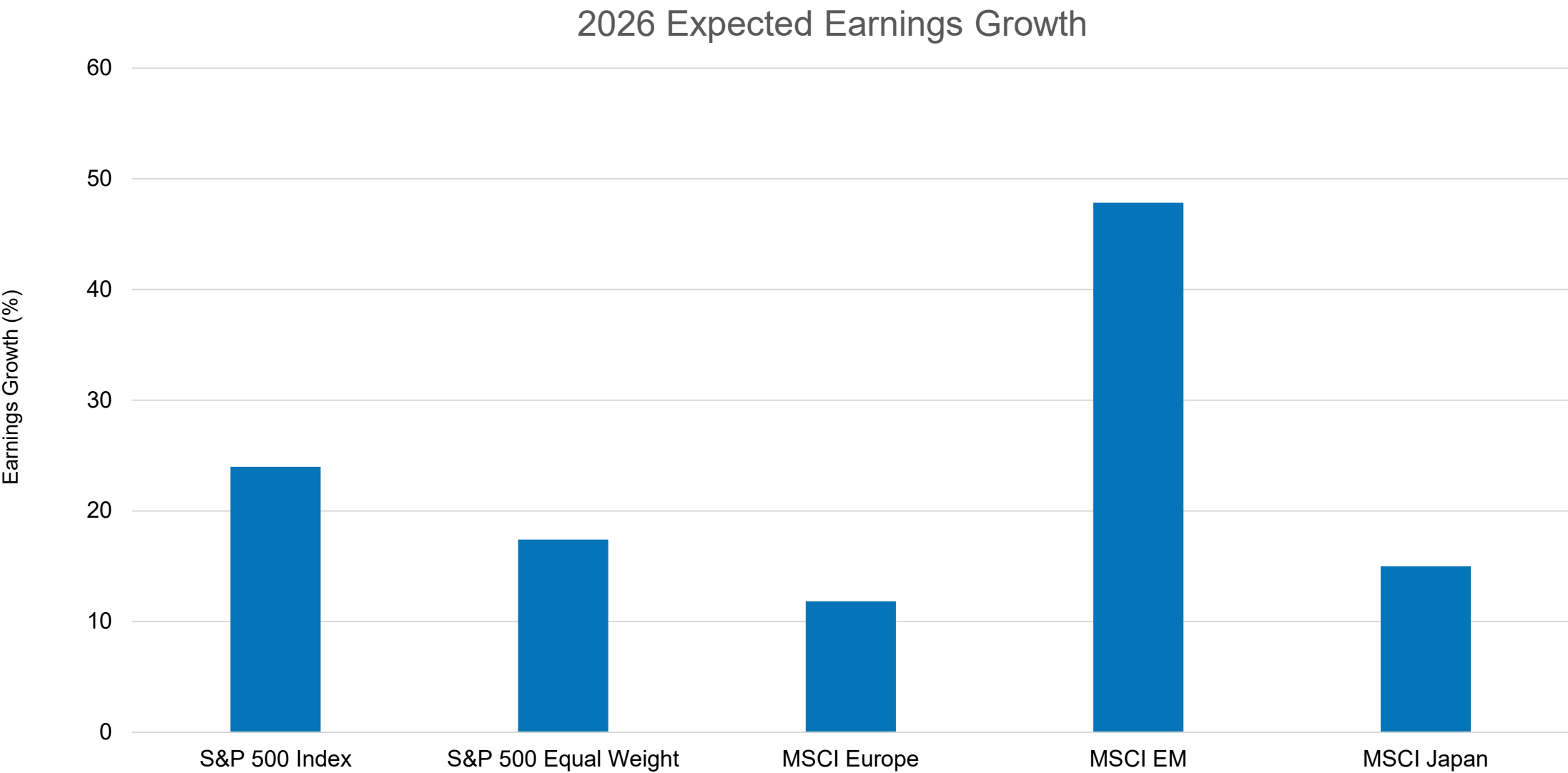

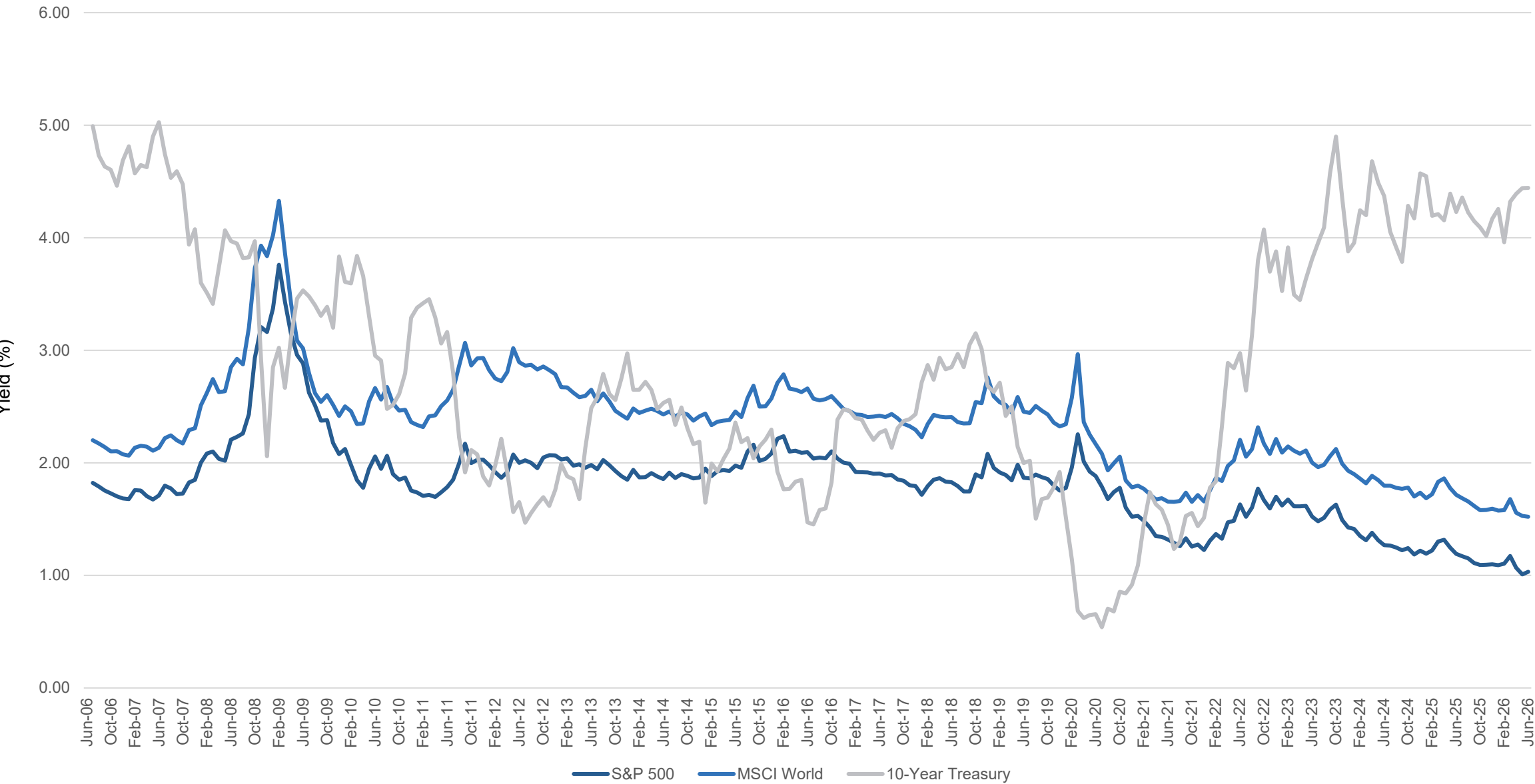

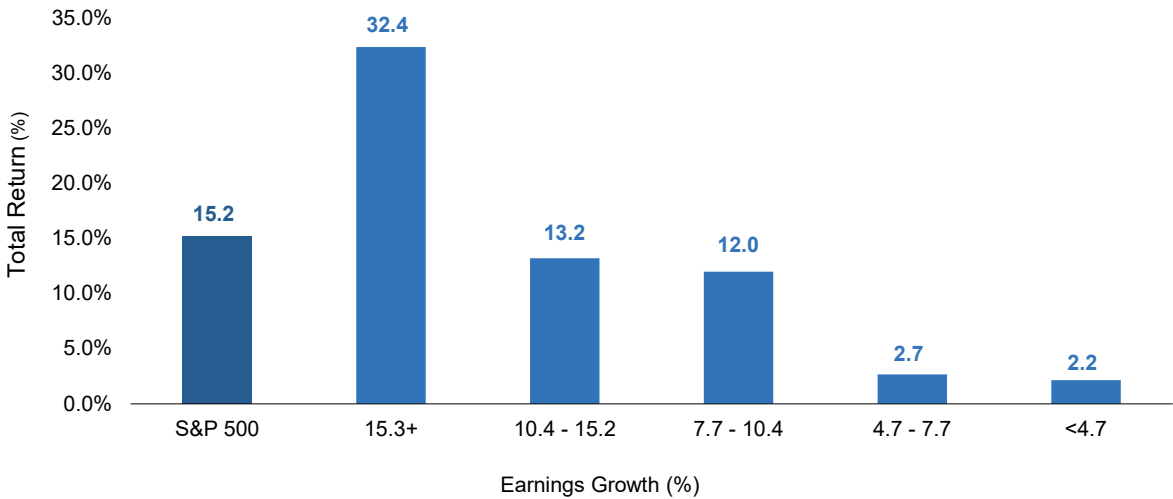
Yields Over Time



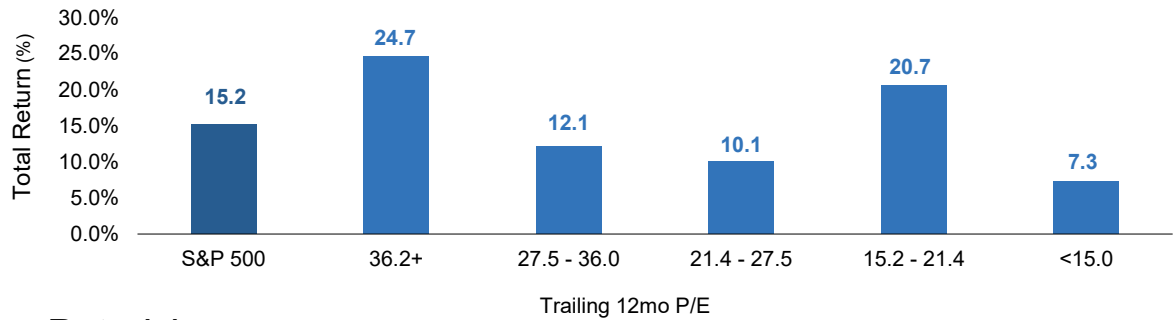

S&P 500 Index: 3-month Return Analysis

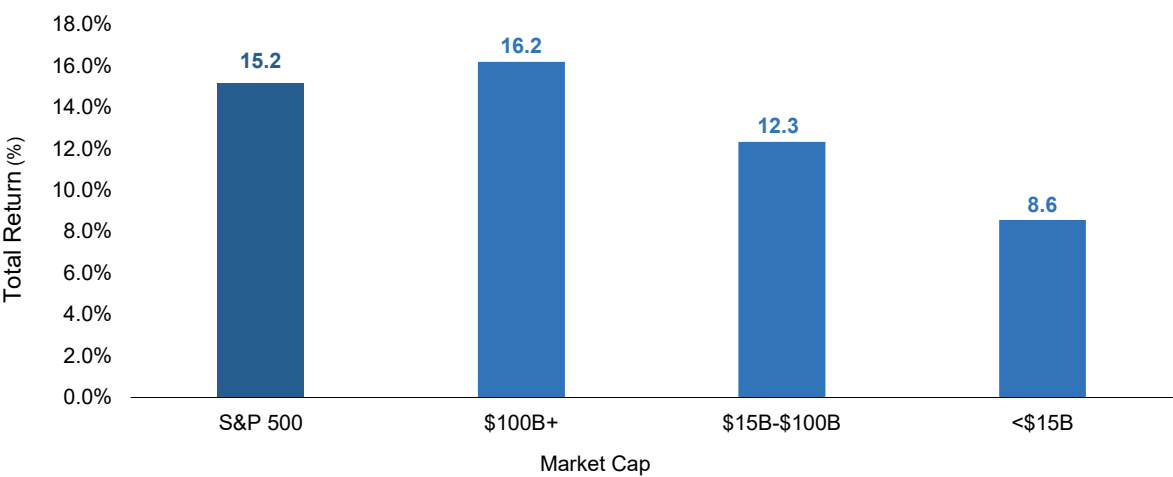
3-5 Year Earnings Growth (%)



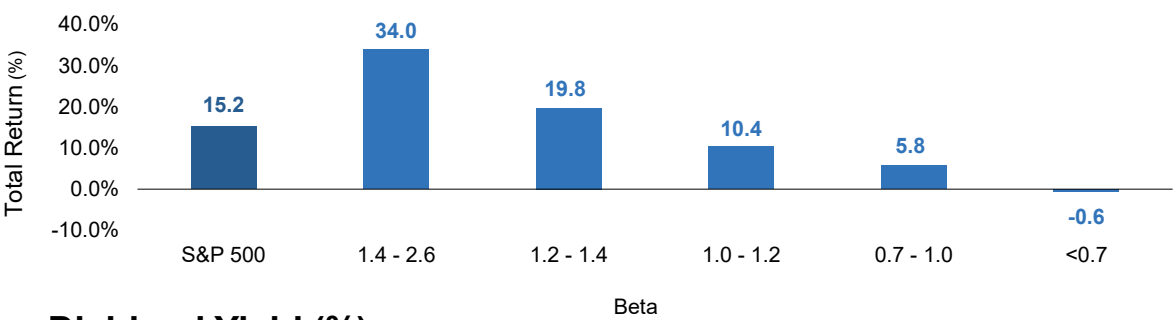
Trailing 12 Month P/E (x)



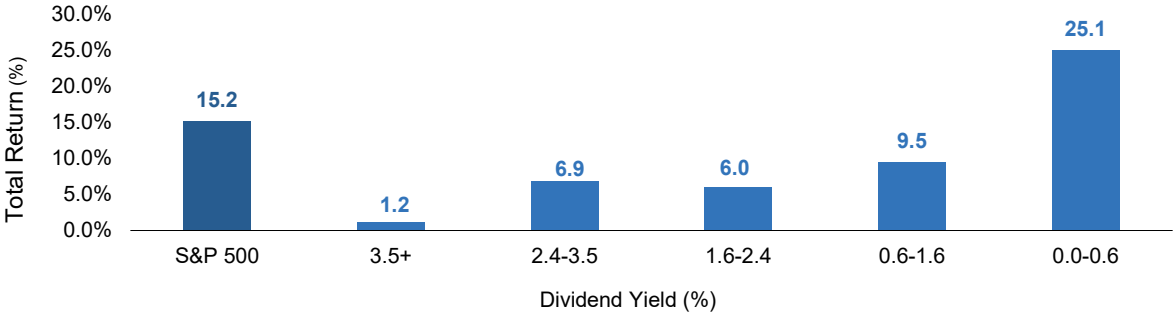

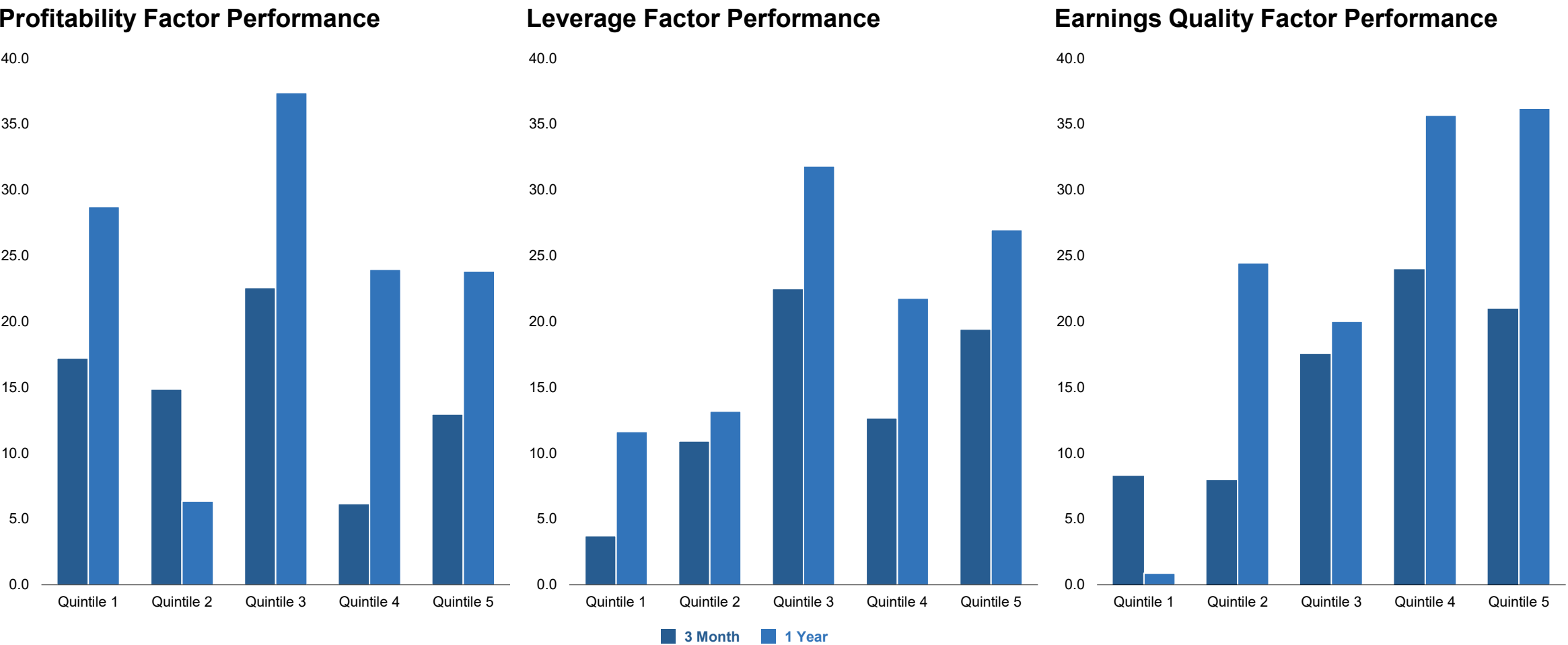


Dividend Yield (%)

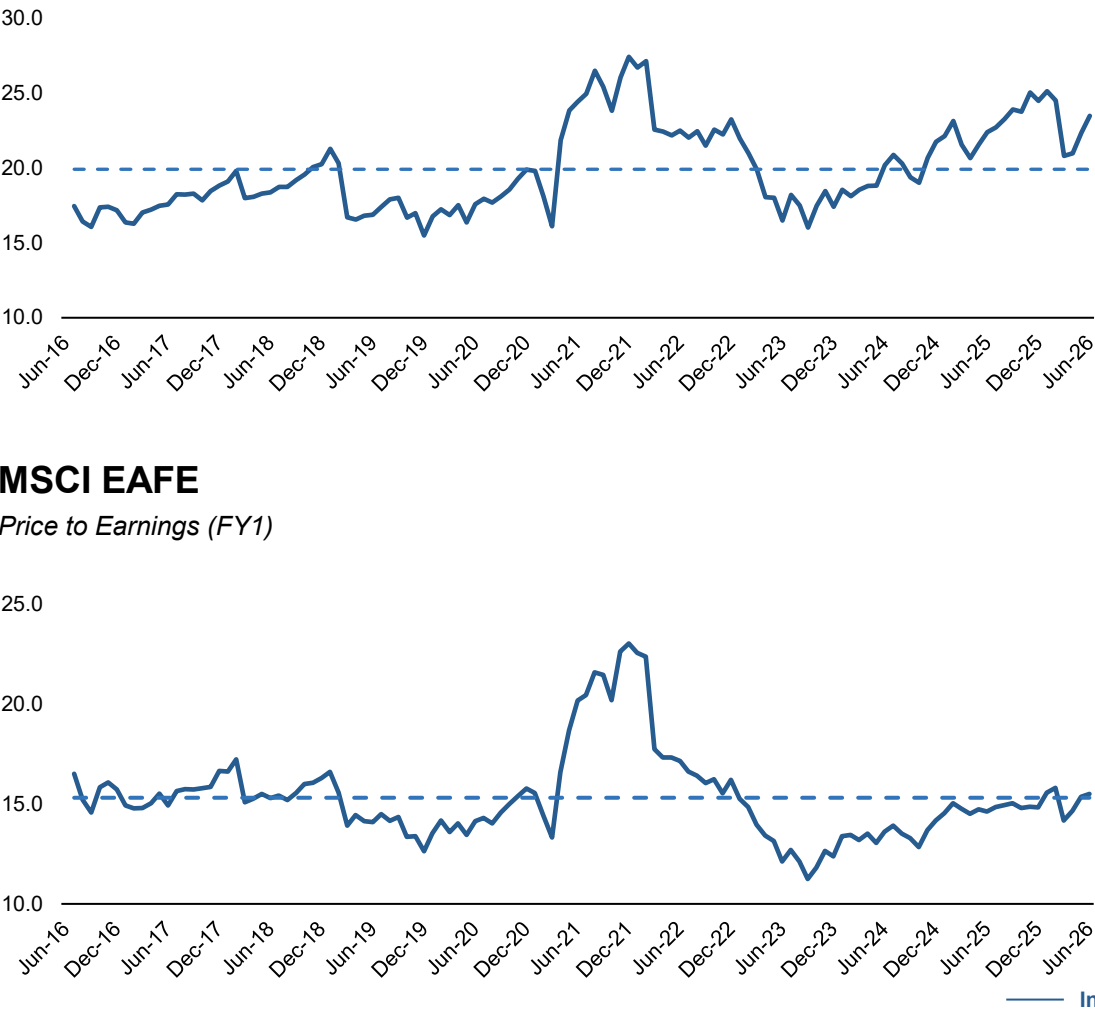

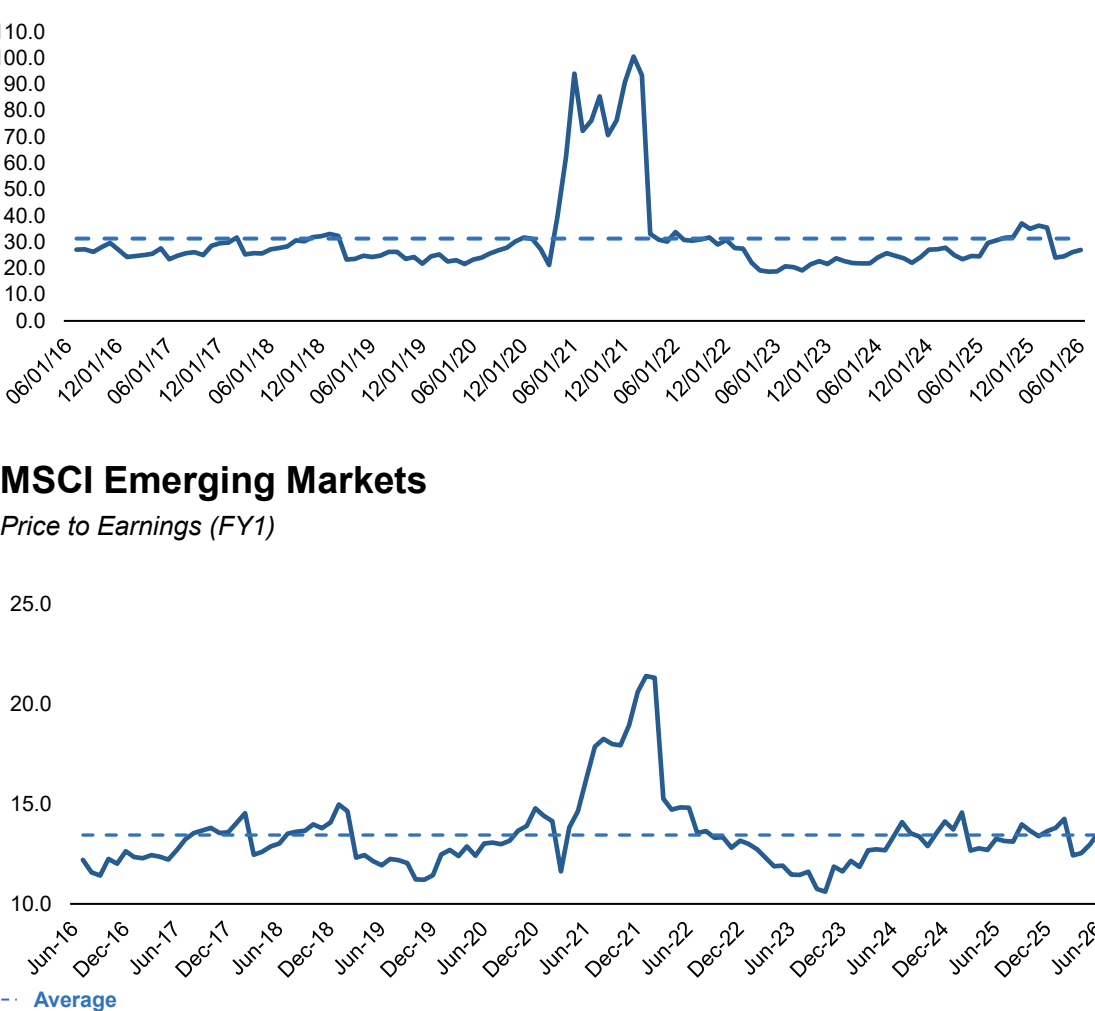

Price to Earnings (FY1)



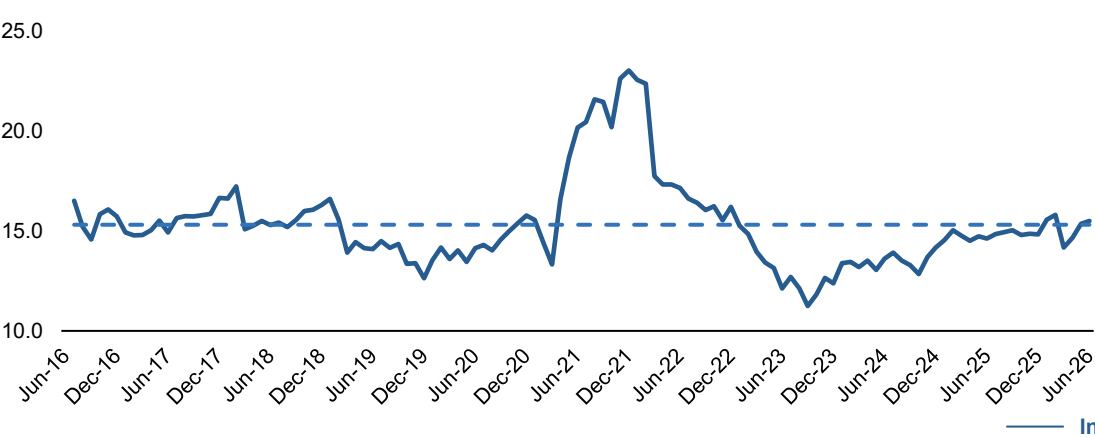

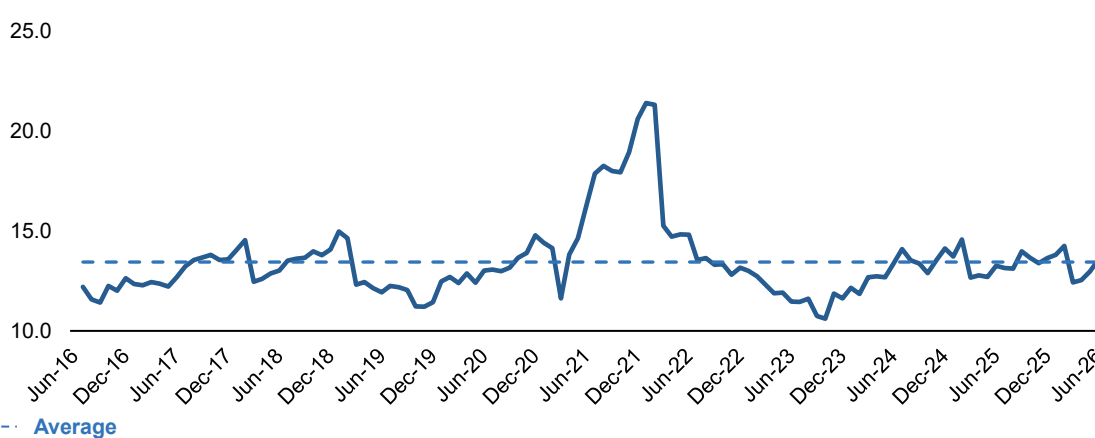
MSCI EAFE

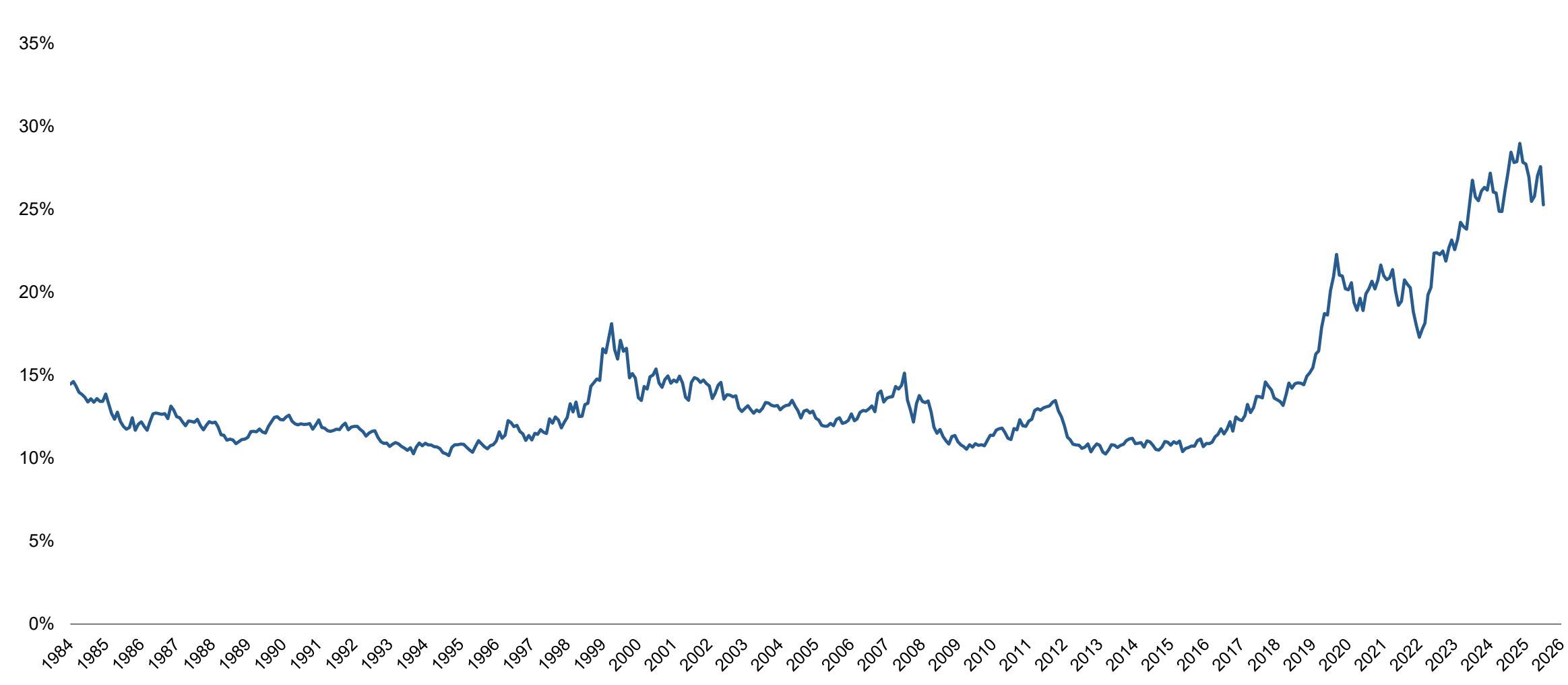

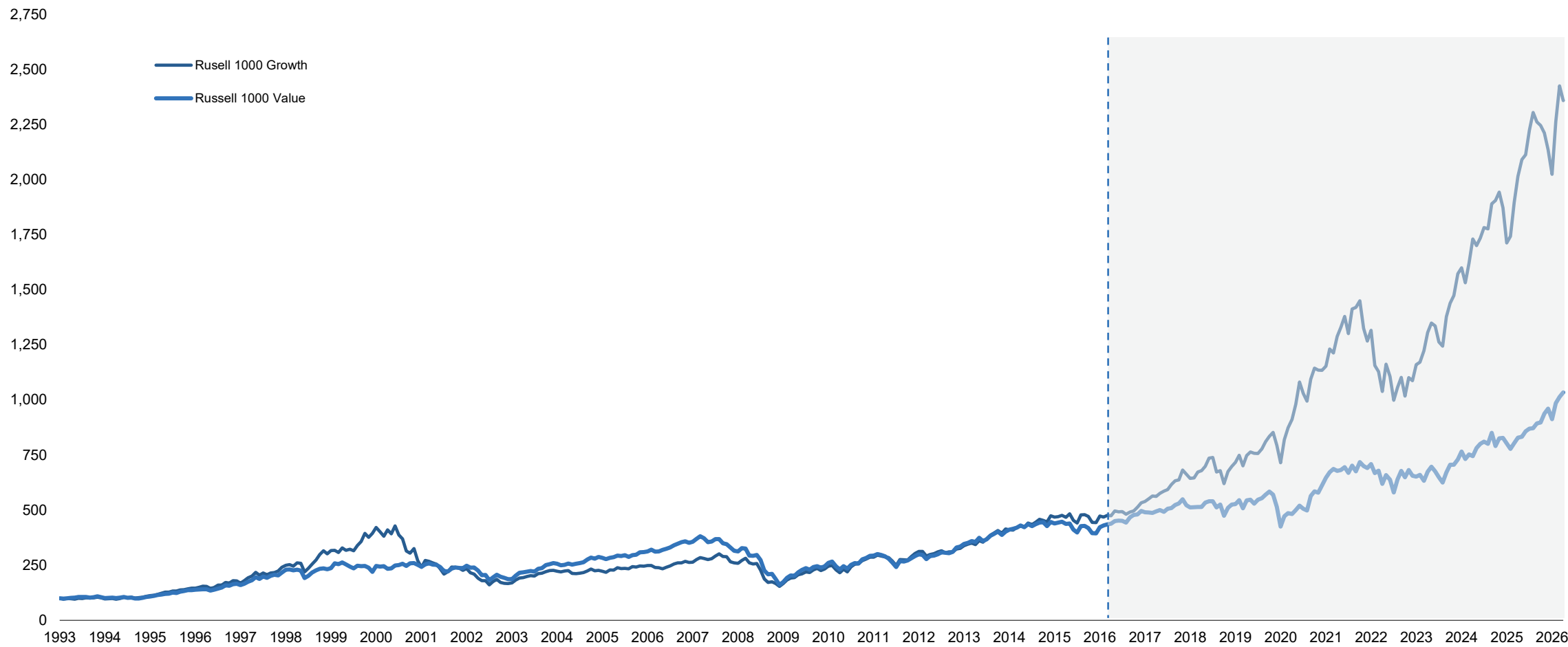

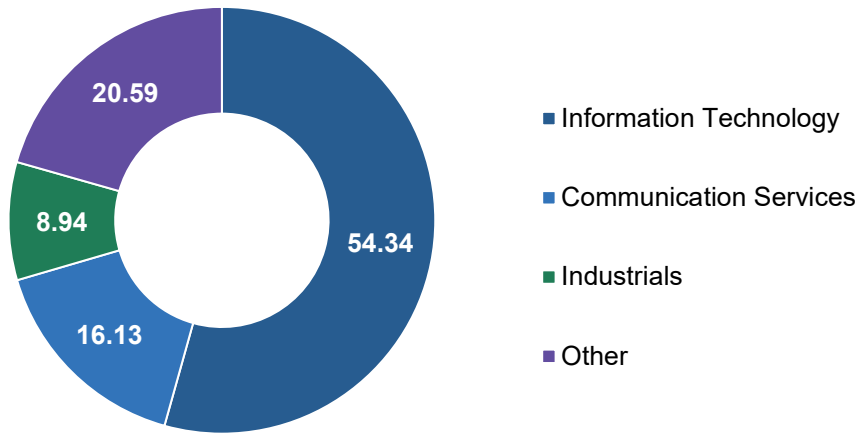

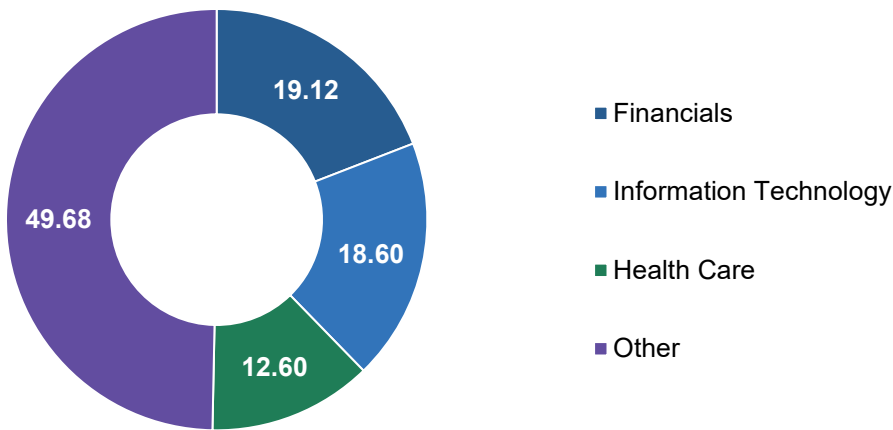

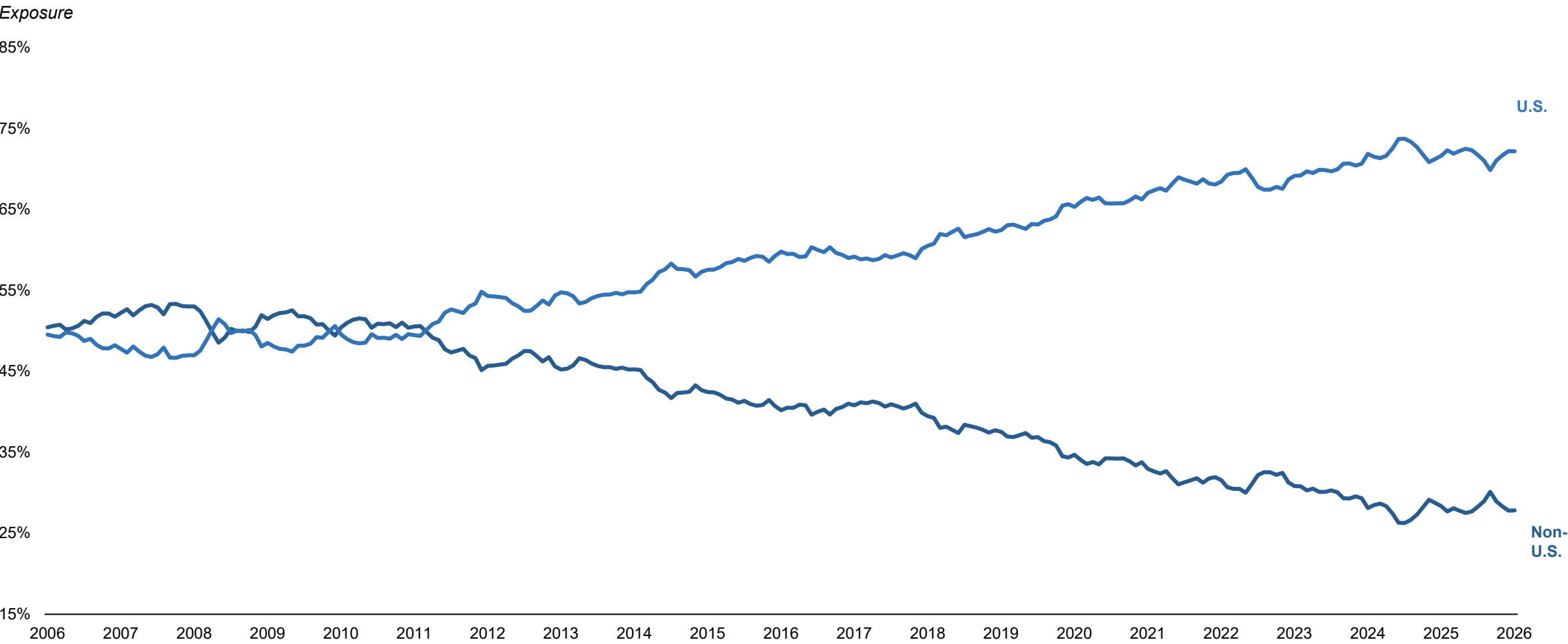

Index Exposure to U.S. vs. Non-U.S. Over Time

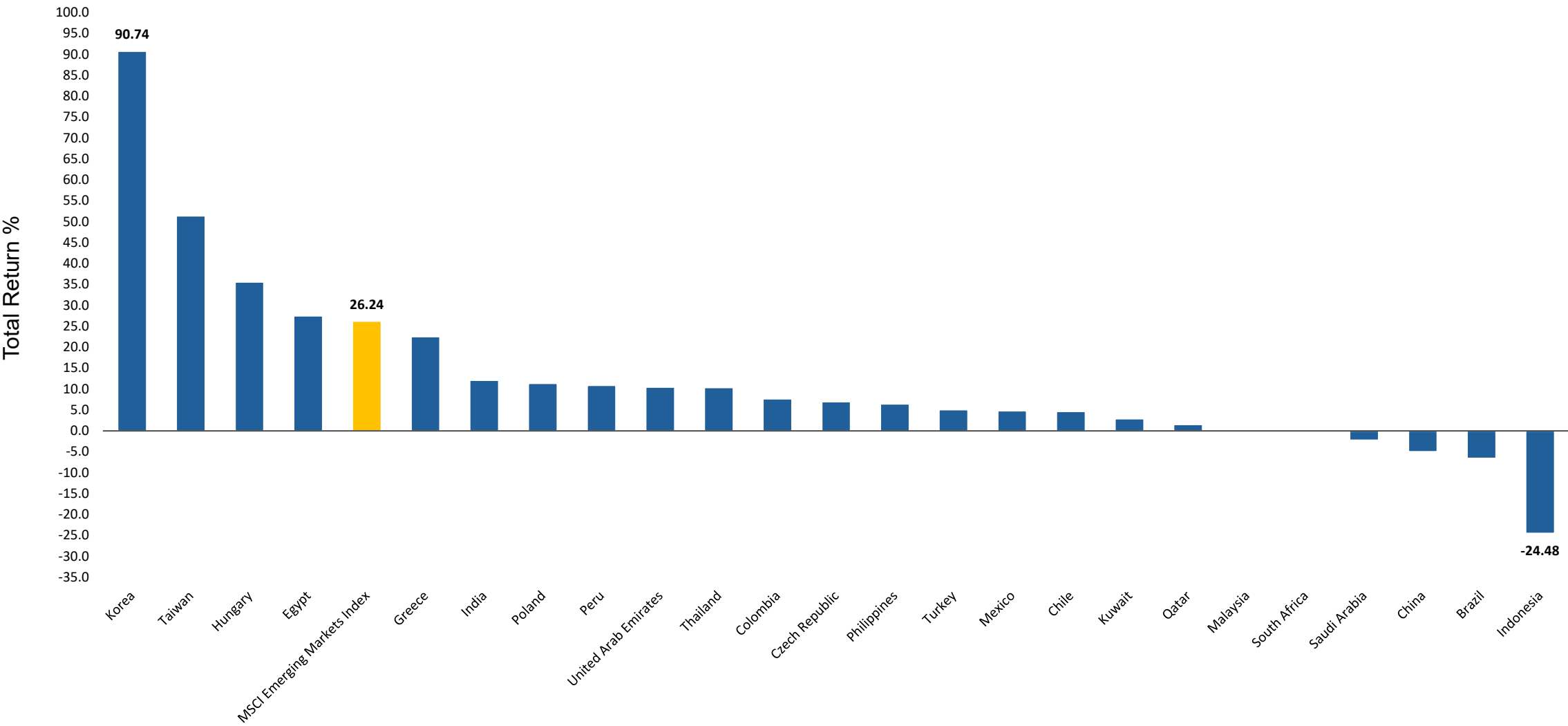
MSCI World - Country breakdown (6/30/2006 - 6/30/2026)
