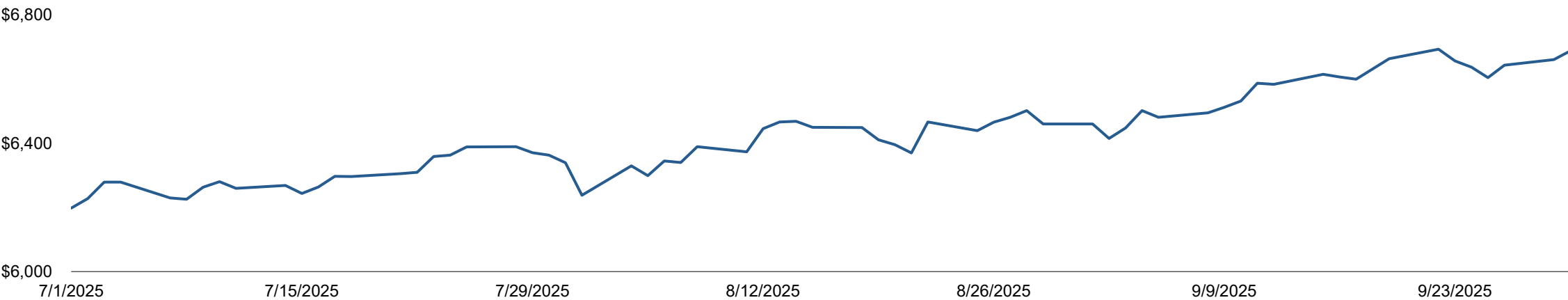

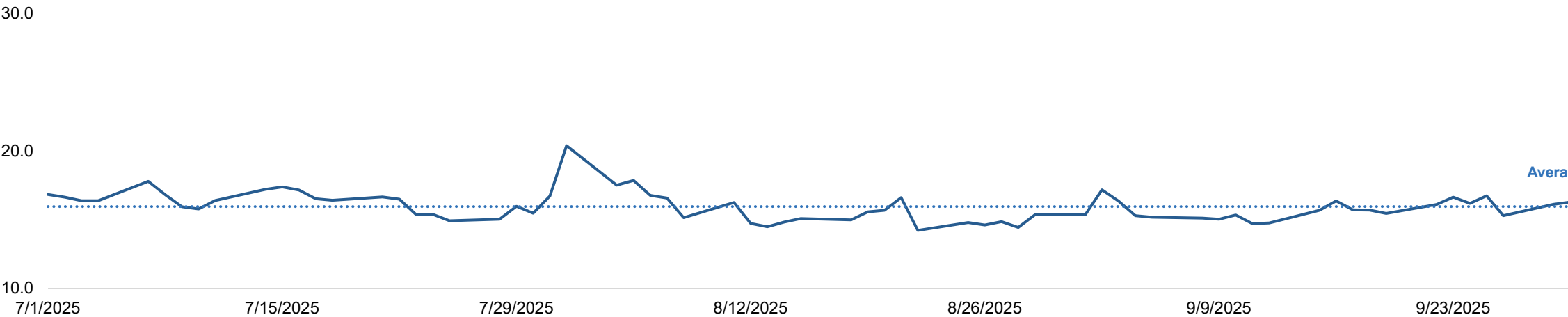

S&P 500 Index



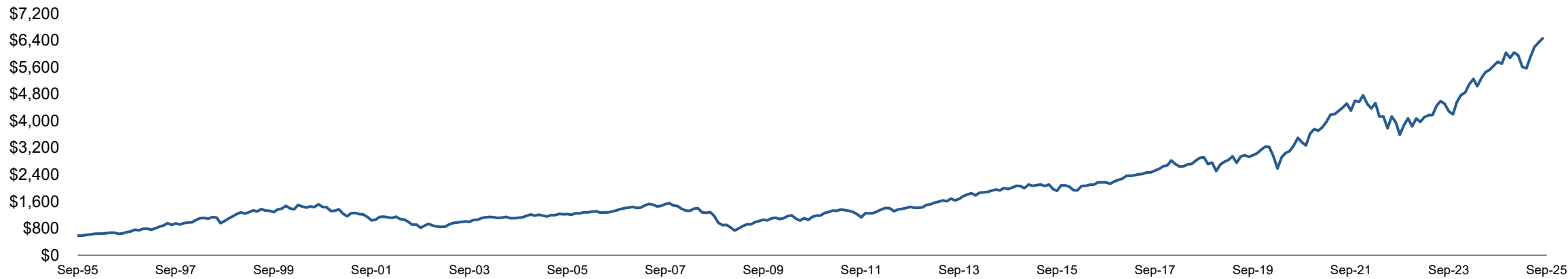
CBOE Market Volatility Index (VIX)



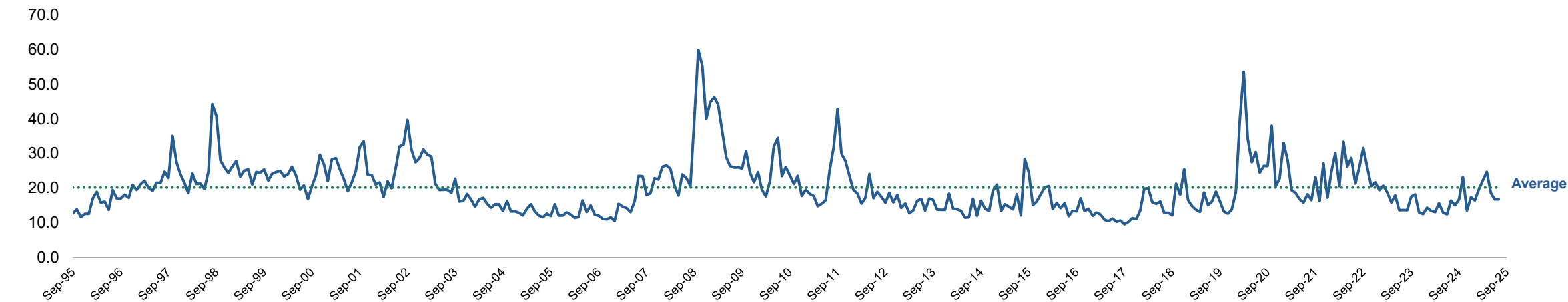

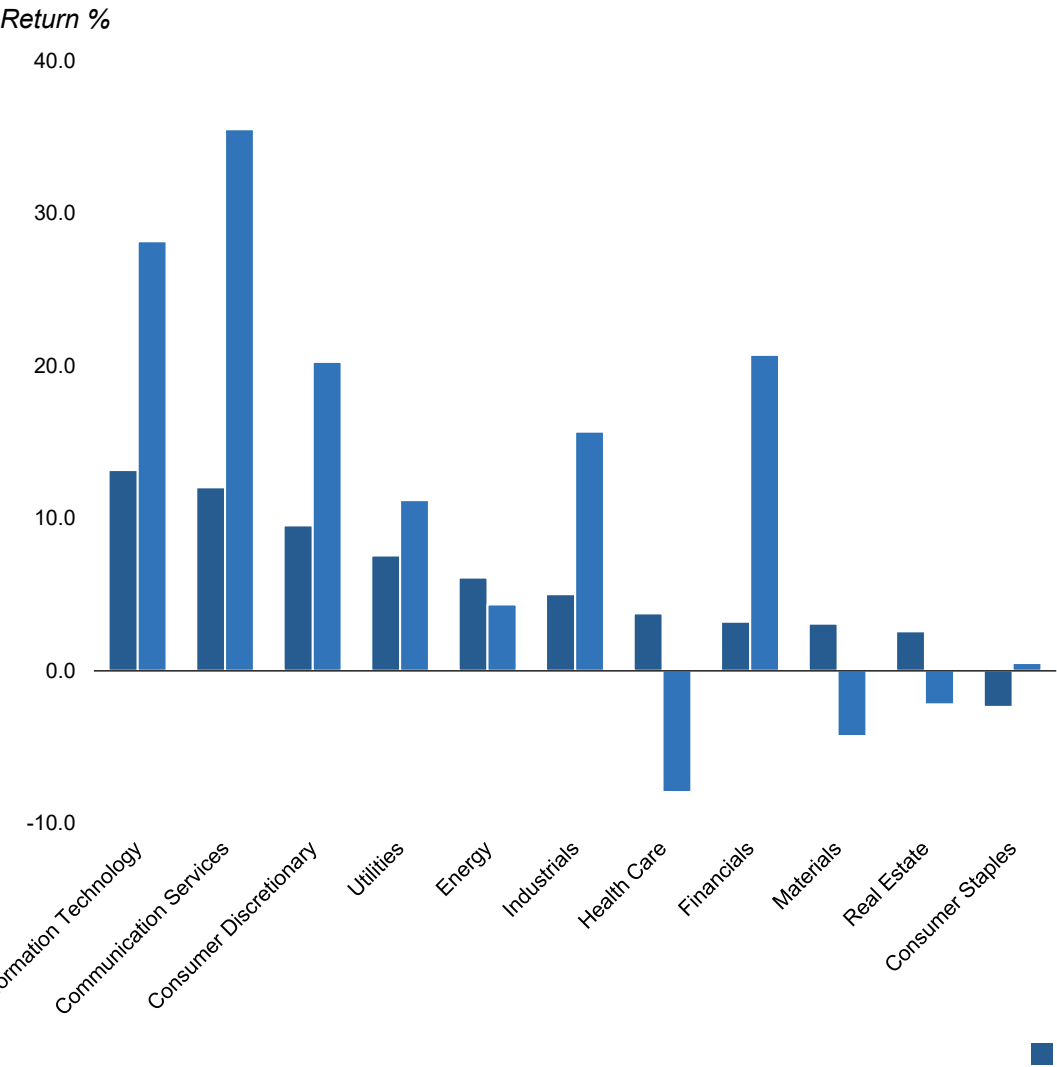

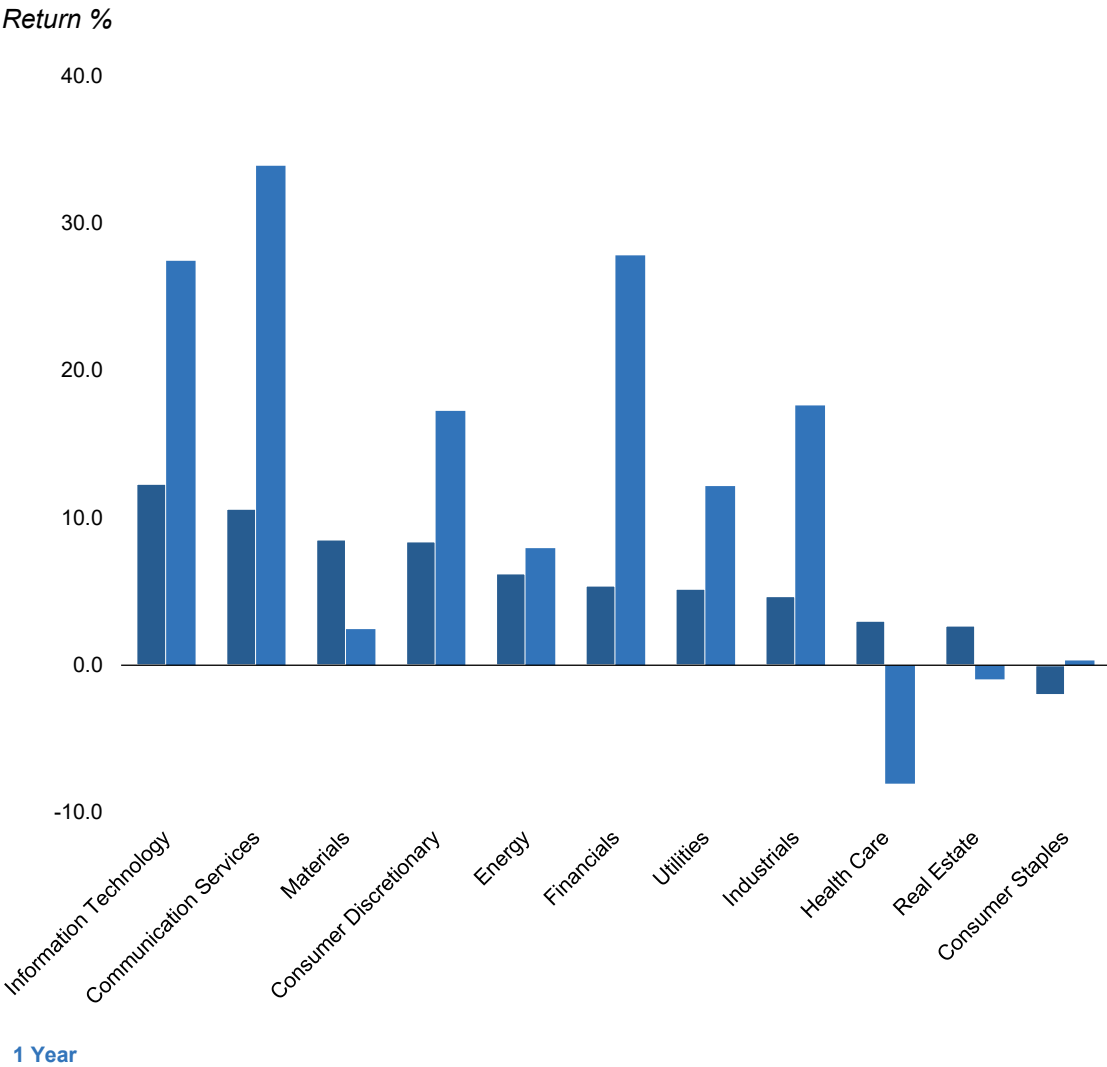

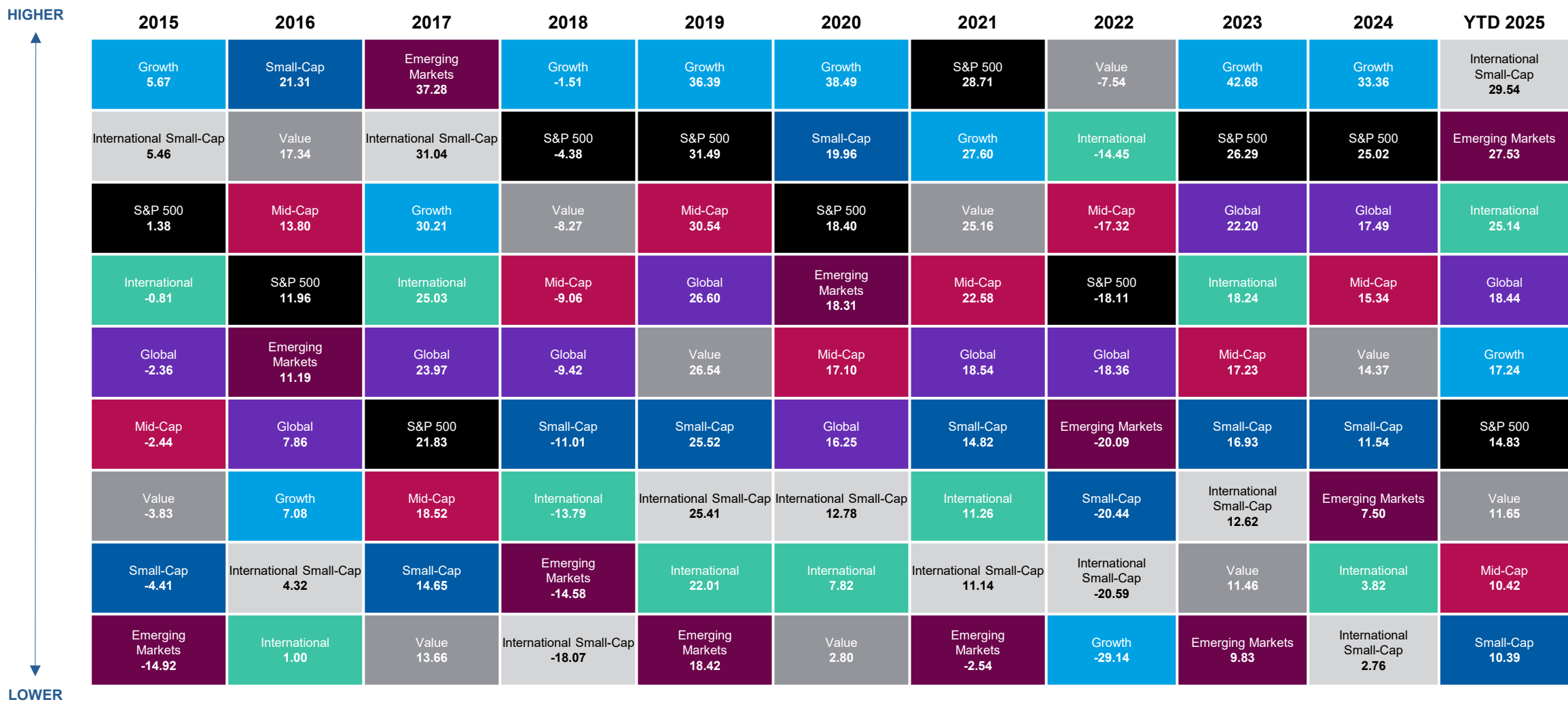

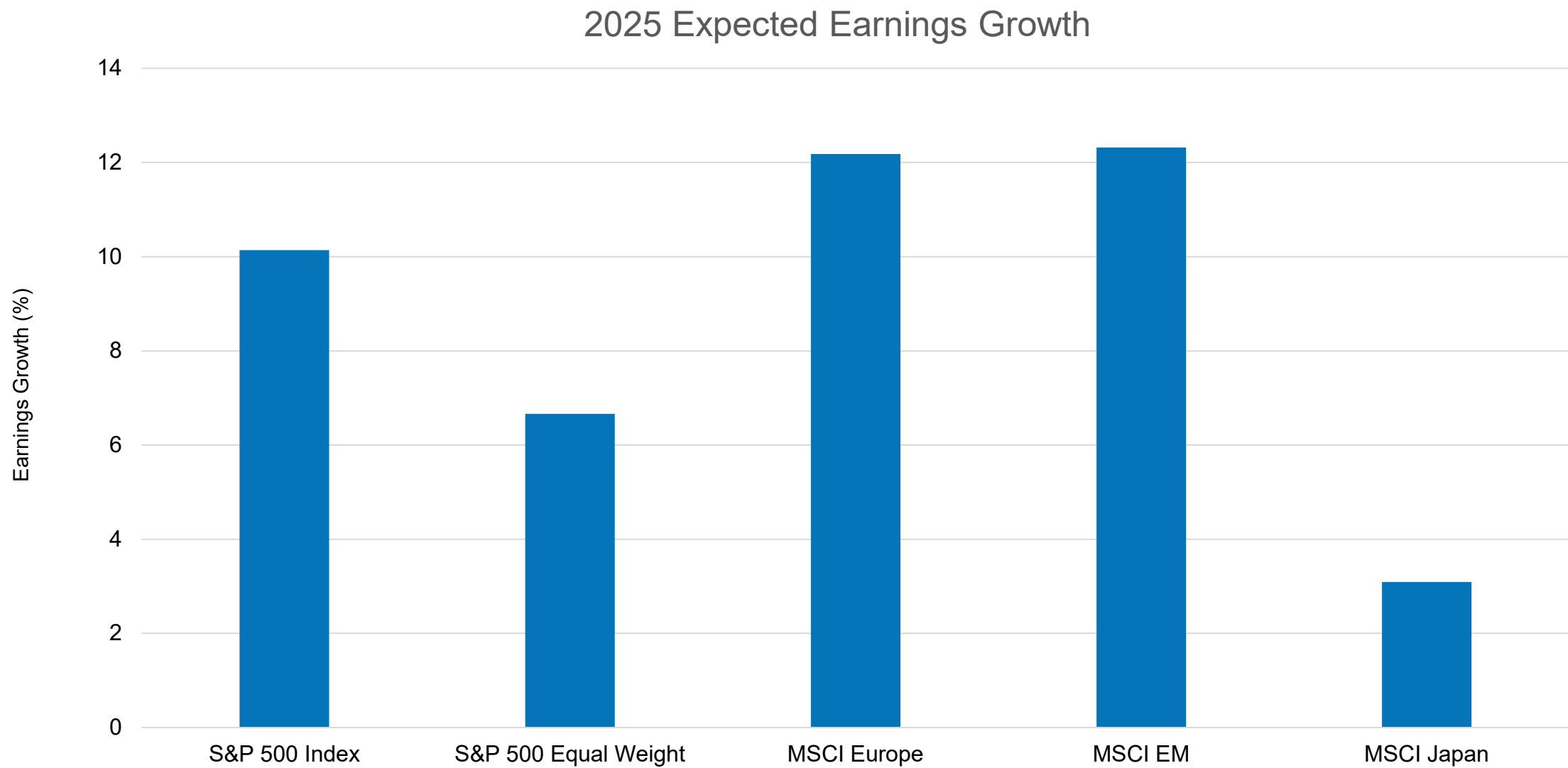

Asset Class Return Analysis (%)



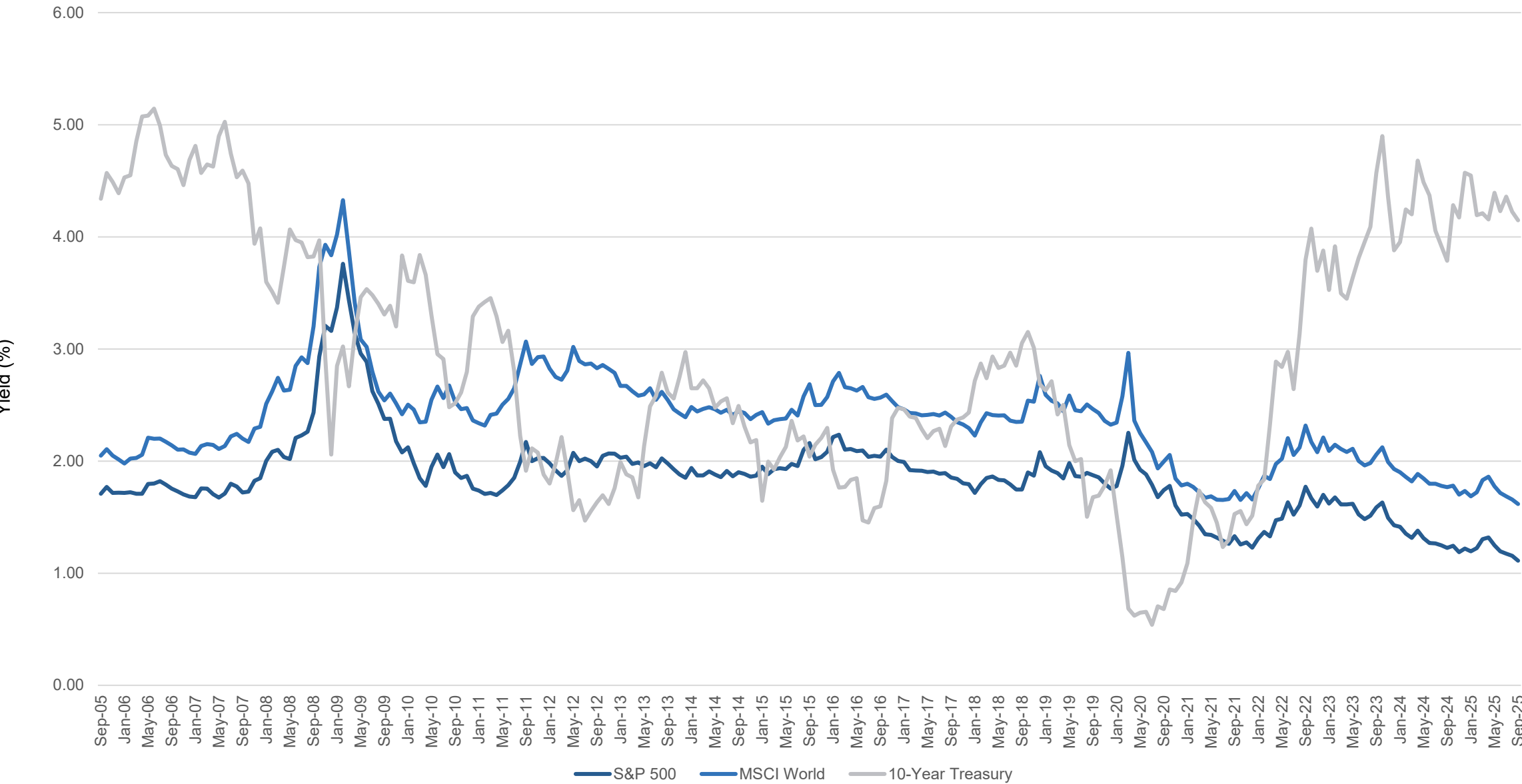

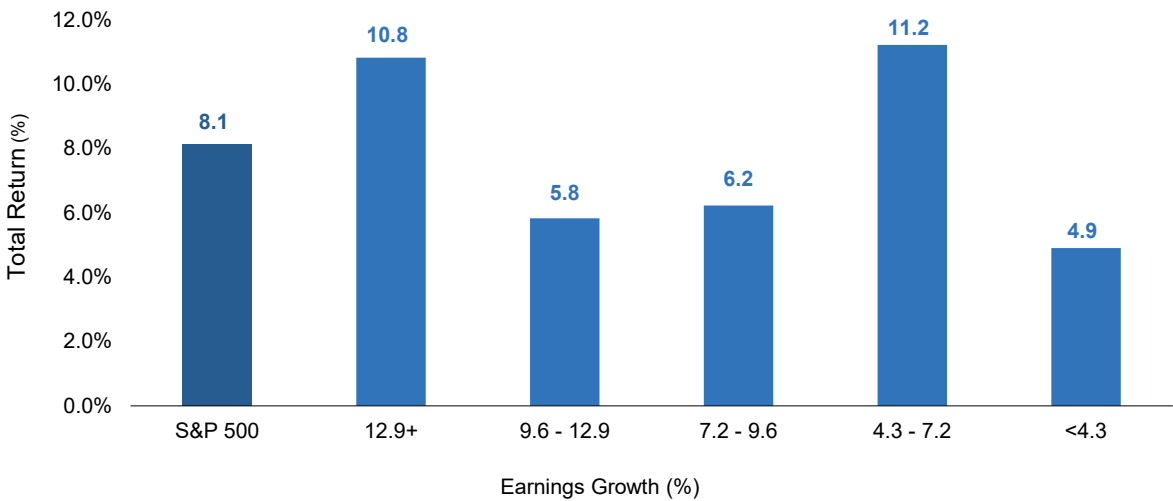
Yields Over Time



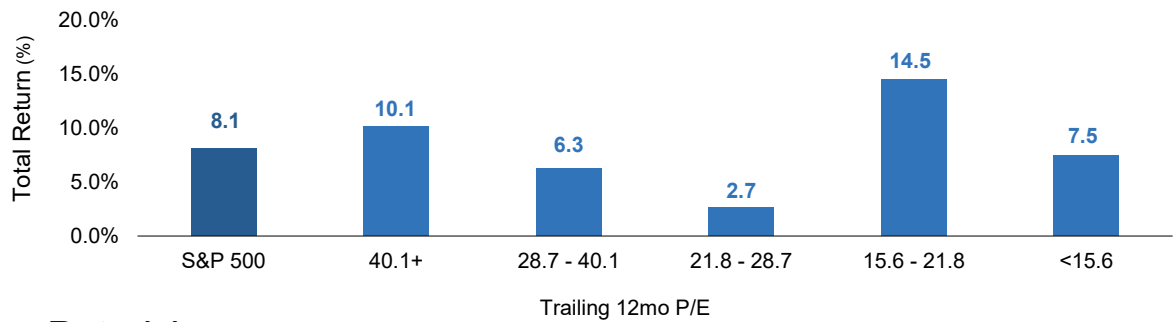

S&P 500 Index: 3-month Return Analysis

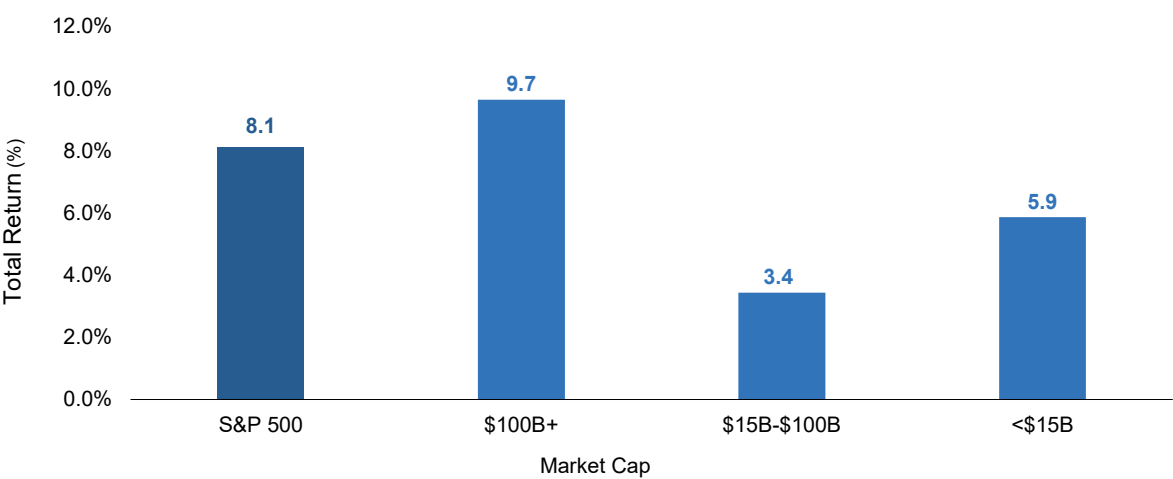
3-5 Year Earnings Growth (%)



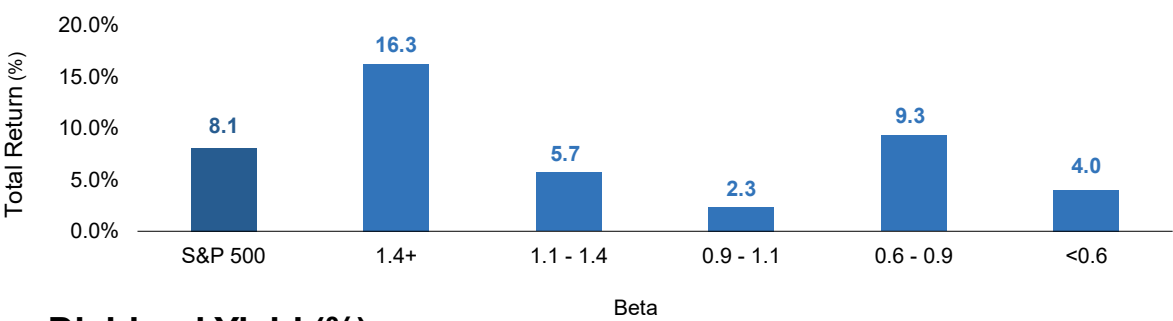
Trailing 12 Month P/E (x)



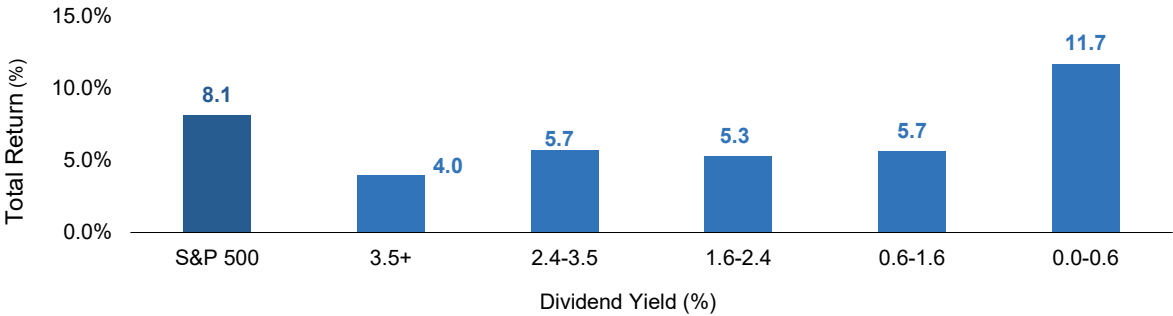

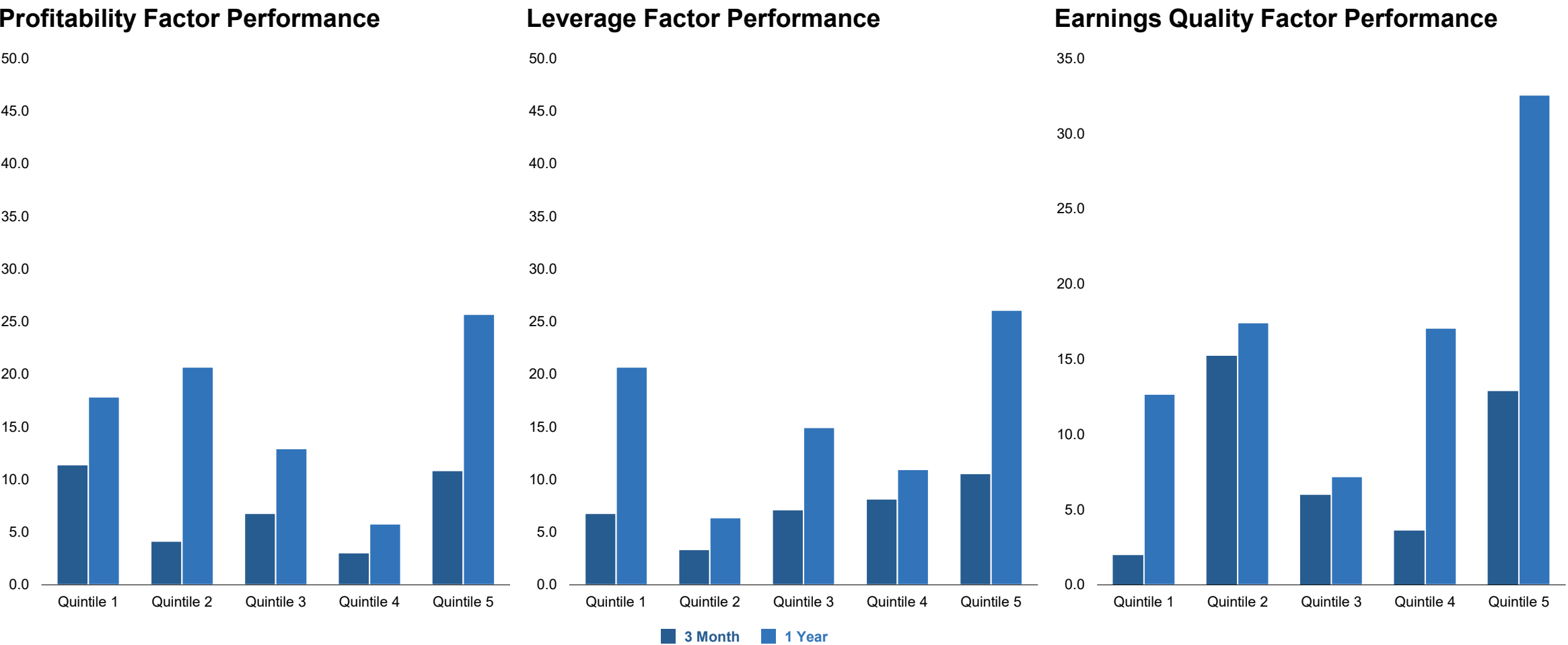


Dividend Yield (%)

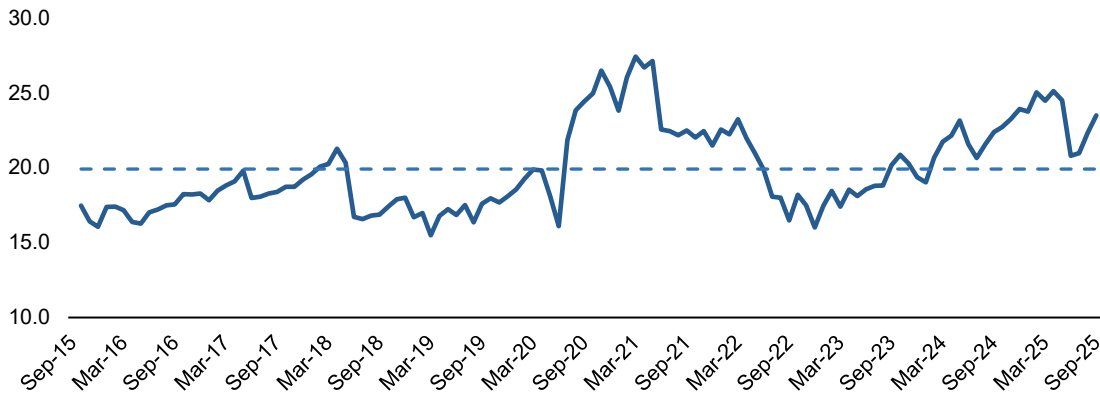

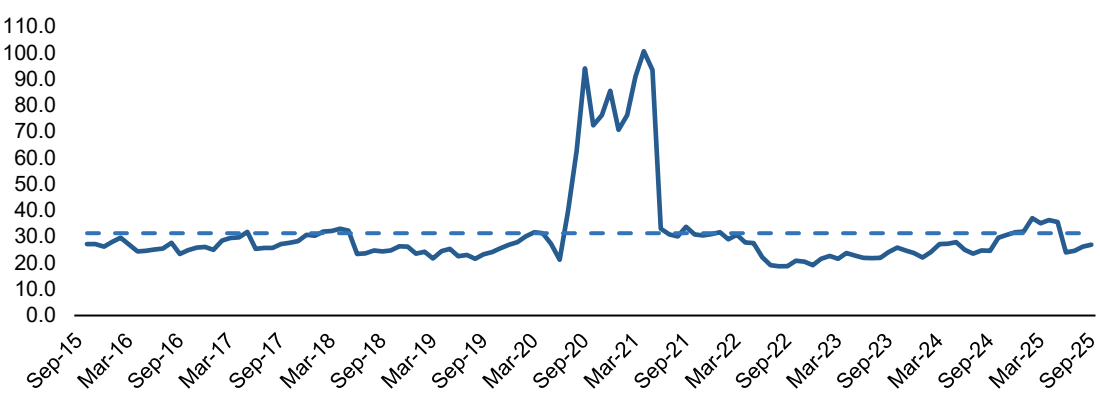

Price to Earnings (FY1)



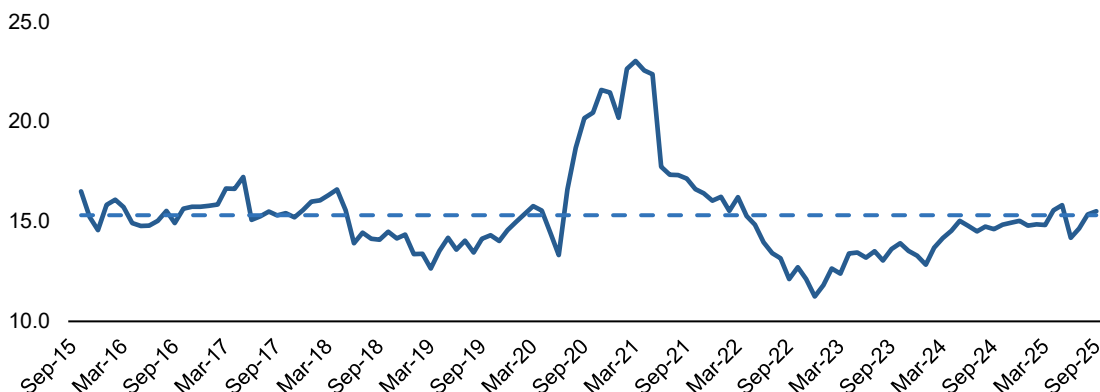

Price to Earnings (FY1)



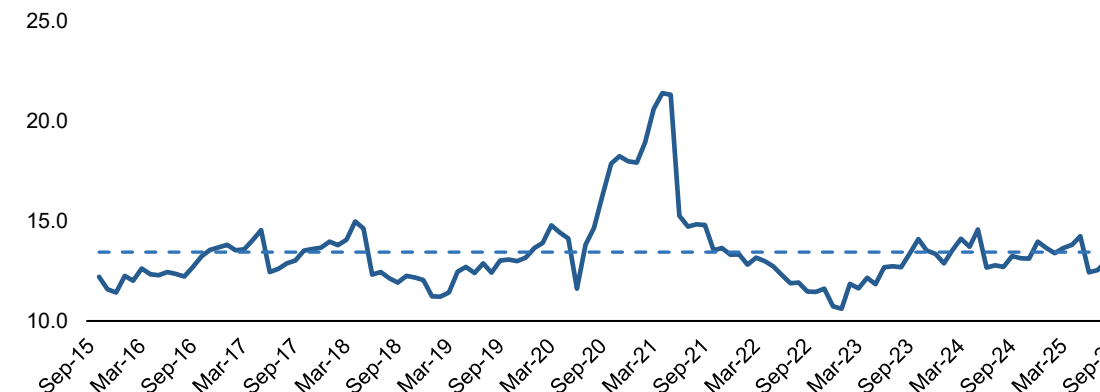
MSCI EAFE

Price to Earnings (FY1)

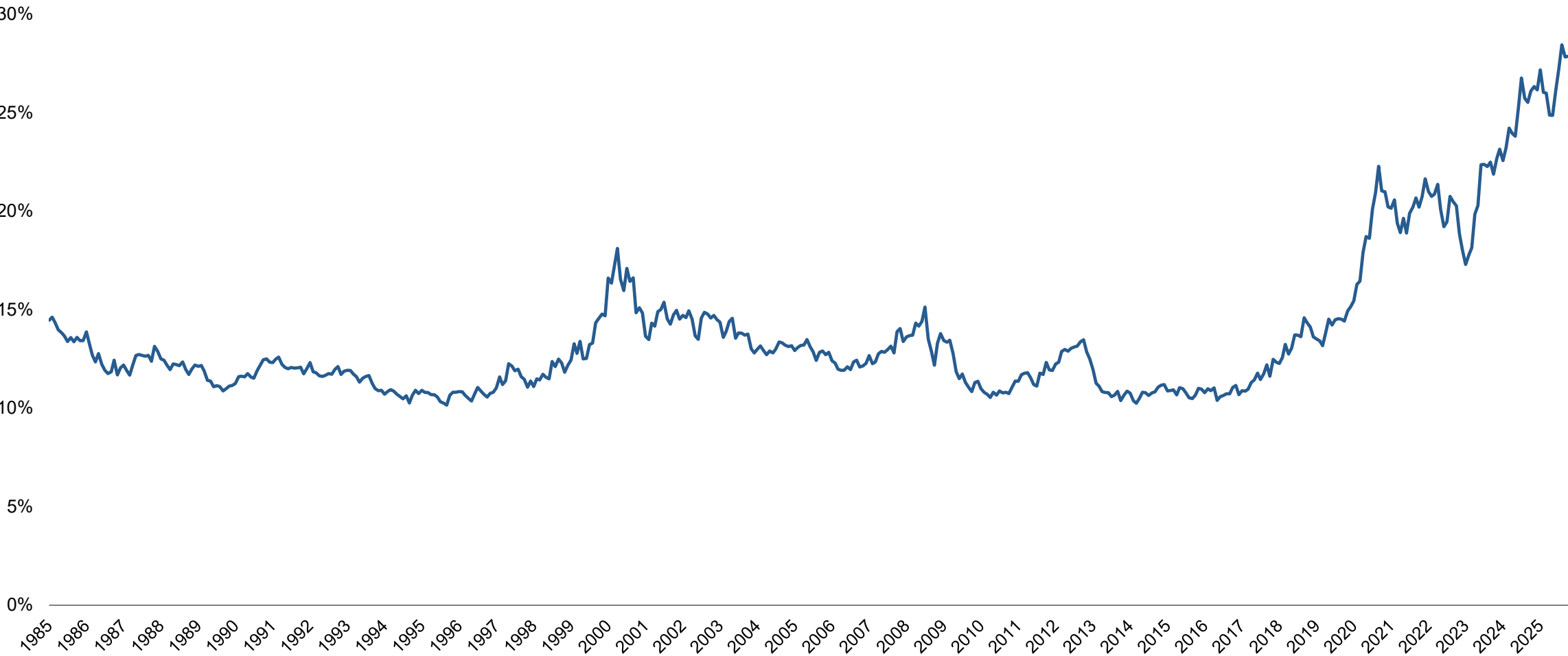

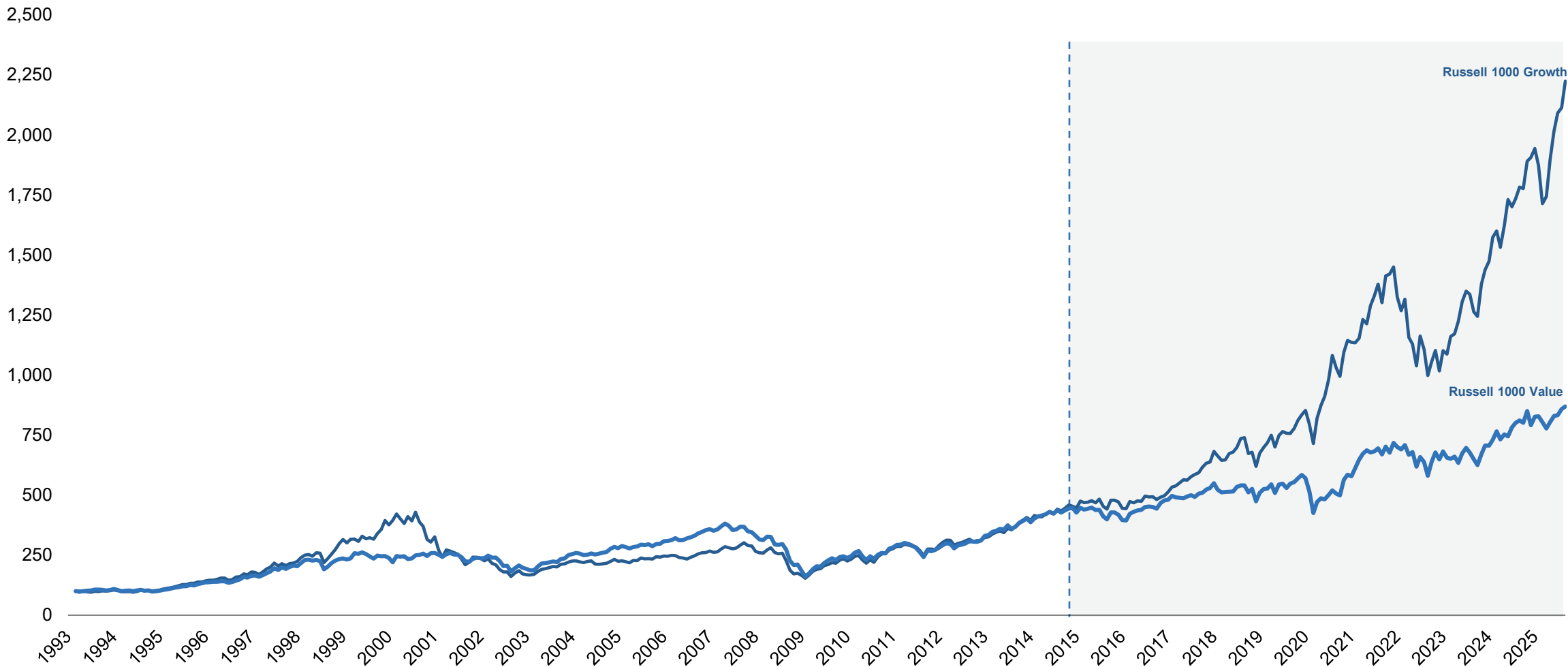

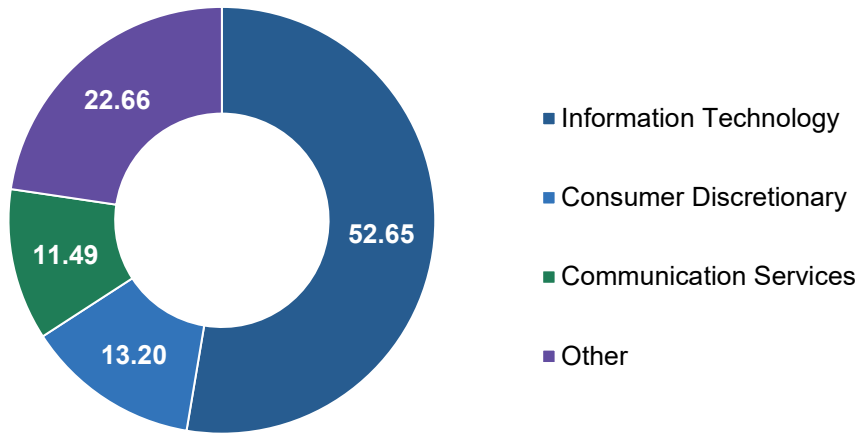

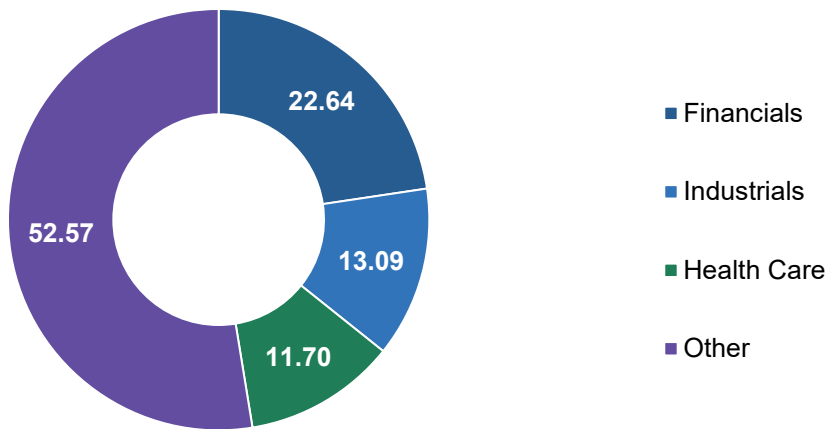

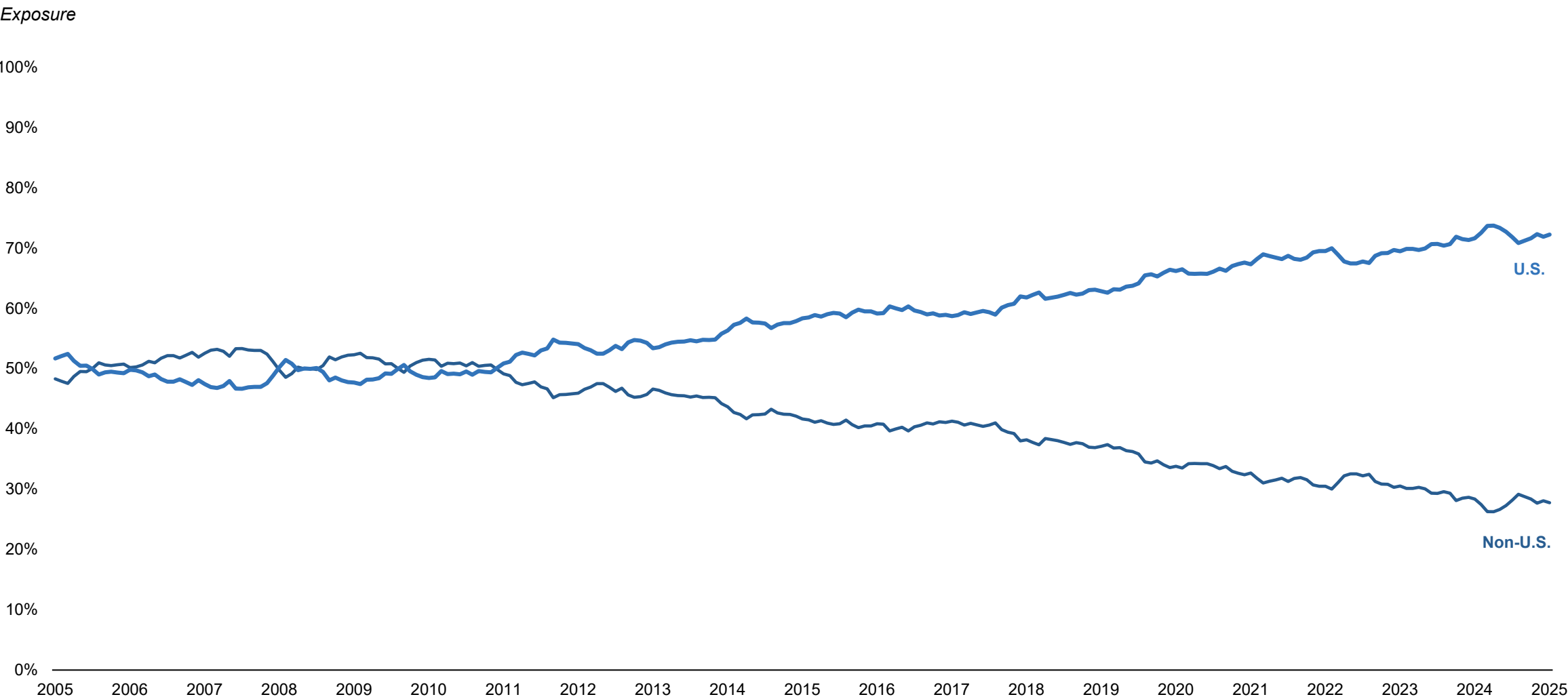

Index Exposure to U.S. vs. Non-U.S. Over Time

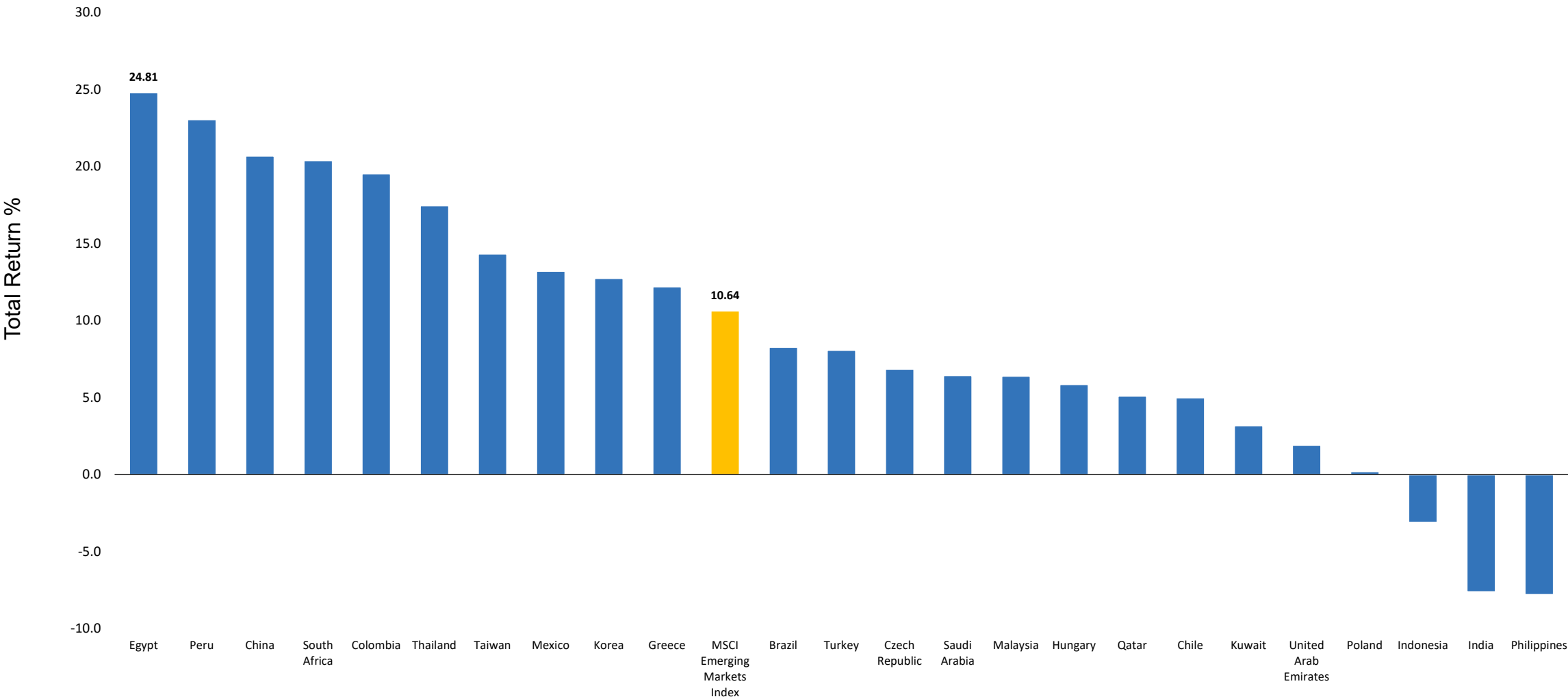
MSCI World - Country breakdown (9/30/2005 - 9/30/2025)
